### **BILL NO. 23 OF 2015**

## **A BILL**

FOR AN ACT TO APPROPRIATE A SUM OF THREE BILLION, NINETY MILLION, EIGHT HUNDRED FORTY THOUSAND, AND THREE HUNDRED TWENTY DOLLARS FOR THE ORDINARY SERVICES OF GOVERNMENT FOR THE YEAR ENDING 31 DECEMBER 2016

ENACTED by the Parliament of the Republic of Fiji—

Short title and commencement

- 1.—(1) This Act may be cited as the 2016 Appropriation Act 2015.
- (2) This Act comes into force on 1 January 2016.

#### Appropriation of \$3,090,840,320

**2.** A sum of \$3,090,840,320 is to be issued from the Consolidated Fund or other funds of the State, and applied to the ordinary services of the Government for the year ending 31 December 2016, and such sum is to be appropriated for the purposes specified in Schedules 1 and 2 and also the 2016 Budget Estimates.

#### Government Borrowing

- **3.**—(1) The Government borrowing for 2016 shall not exceed the sum of \$445,436,658.
- (2) Notwithstanding any other written law and for the purpose of subsection (1), the Minister for Finance may, subject to the approval of Parliament, borrow on behalf of the State by raising loans not exceeding \$445,436,658 in 2016.

#### 2016 APPROPRIATION BILL 2015

#### **EXPLANATORY NOTE**

(This note is not part of the Bill and is only intended to indicate its general effect)

#### 1.0 BACKGROUND

1.1 This Bill makes provision for the estimates of capital and current expenditure for the ordinary services of the Government for the year 2016.

#### 2.0 CLAUSES

- 2.1 Clause 1 provides for the short title and the commencement provision.
- 2.2 Clause 2 appropriates the sum of \$3,090,840,320 for the ordinary services of the Government for the year ending 31 December 2016 for the purposes specified in Schedules 1 and 2 and the 2016 Budget Estimates.

Clause 3 provides that the Government borrowing for 2016 shall not exceed the sum of \$445,436,658.

#### 3.0 MINISTERIAL RESPONSIBILITY

3.1 The Act comes under the responsibility of the Minister for Finance.
