Oral Questions

- 92/2016 Hon. Prem Singh to ask the Minister for Defence, National Security and Immigration Would the Minister inform Parliament what has been the progress of investigations in the case of the South African Diplomat, who caused the death of Ashneel Singh by dangerous and drink driving in October last year and whether the family of Ashneel Singh has been compensated by the South African Government.
- 93/2016 Hon. Dr Brij Lal to ask the Minister for Industry, Trade and Tourism The World Trade Organisation (WTO) Trade Facilitation Agreement (TFA) was endorsed by the WTO Ministerial Conference in 2013. Can the Minister kindly explain what the Trade Facilitation Agreement is.
- 94/2016 Hon. Ashneel Sudhakar to ask the Minister for Defence, National Security and Immigration Can the Minister inform this House, as to what plans the Ministry has in enhancing Fiji's surveillance capability in terms of the monitoring of the EEZ and Search and Rescue.
- 95/2016 Hon. Mohammed Dean to ask the Minister for Education, Heritage and Arts Can the Minister elaborate on the progress so far to improve the level of Special School Education in Fiji as prioritised in the 2016 Budget.
- 96/2016 Hon. Alivereti Nabulivou to ask the Minister for Defence, National Security and Immigration Can the Minister update this House as to the status and progress of the Hydrographic Unit and what benefits can Fiji reap from this Department.
- 97/2016 Hon. Salote Radrodro to ask the Minister for Women, Children and Poverty Alleviation Can the Minister inform the House as to what verifiable indicators/benchmark has been set by the Ministry to monitor progress in combating violence against women and children in Fiji.
- 98/2016 Hon. Aseri Radrodro to ask the Attorney-General and Minister for Finance, Public Enterprises, Civil Service and Communications Can the Minister inform the House on how Government proposes to extend the national television coverage of Fiji One to areas

outside of the main centre's that are not able to catch the signal coverage of Fiji One.
