Oral Questions

- 113/2016 Hon. Ratu Suliano Matanitobua to ask the Minister for Youth and Sports – Can the Minister inform the House if all athletes travelling on Government Sponsorship to Rio are insured for injuries.
- 114/2016 Hon. Jilila Kumar to ask the Minister for Industry, Trade and Tourism – Can the Minister brief this House on what is the Department of Co-operatives role in fostering and empowering women in co-operative business.
- 115/2016 Hon. Netani Rika to ask the Minister for Industry, Trade and Tourism Fiji has won the right to host an international event for runners around the world the 21st Inter-Hash Super meet in May 2018 Can the Minister brief this House of the benefits it will bring to the country.
