Oral Questions

- Hon. Aseri Radrodro to ask the Minister for Local Government, Housing and Environment, Infrastructure and Transport There is an increasing number of fatalities on our roads despite the wide publicity of the National Decade for Road Safety currently on going. Can the Minister inform the House how Government proposes to effectively tackle and reduce road fatalities.
- Hon. Aseri Radrodro to ask the Minister for Local Government, Housing and Environment, Infrastructure and Transport Can the Minister inform the House of the impact of Government's Policy that extended nightclub hours till morning, and patrons coming out of nightclubs in the early hours are not able to secure public transport vehicles which is a contributing factor to deaths of two youths in Samabula in recent weeks.
- Hon. Mosese Bulitavu to ask the Attorney-General and Minister for Finance, Public Enterprises, Civil Service and Communications

 Can the Minister explain what benefits will Fiji get after signing the Paris Agreement.
- Hon. Viliame Gavoka to ask the Minister for Agriculture, Rural and Maritime Development and National Disaster Management Can the Minister inform the House what is Government doing about dredging the Sigatoka and Tuva rivers, as they are now very shallow and quickly flood during periods of rain, posing great threat to communities.
- Hon. Mataiasi Niumataiwalu to ask the Minister for Agriculture, Rural and Maritime Development and National Disaster Management Can the Minister explain how land degradation threatens the sustainable livelihood of future generations with continuing decrease in arable land and soil in Fiji.
- 87/2016 Hon. Ruveni Nadalo to ask the Minister for Education, Heritage and Arts Can the Minister explain the progress on the reconstruction works at Queen Victoria School.
