Oral Questions

- 21/2017 Hon. Aseri Radrodro to ask the Minister for Local Government, Housing and Environment, Infrastructure and Transport – Can the Minister inform this House what is the total cost of the implementation of the street light provisioning of Cuvu back road beginning from the Pacific Green end running along the villages of Naevuevu, Sila, Cuvu, etc ending at the Naidovi junction.
- 22/2017 Hon. Ro Teimumu Kepa to ask the Minister for Education, Heritage and Arts – Can the Minister clarify how are the new textbooks being piloted and trialled for years 12 and 13 before country wide distribution.
- 23/2017 Hon. Salote Radrodro to ask the Attorney-General and Minister for Economy, Public Enterprises, Civil Service and Communications – Can the Minister advise this House on the progress of the National Development Plan Consultation.
- 24/2017 Hon. Anare Vadei to ask the Minister for Health and Medical Services – Can the Minister advise this House on the progress of the implementation of the Free Medicine Programme.
- 25/2016 Hon. Howard Politini to ask the Minister for Defence and National Security – Can the Minister inform this House, on the level of Fiji's (RFMF, Police and Corrections) participation in both UN and Non-UN Peacekeeping Missions around the World.

 - (ii) The breakdown of annual fees collected from licensees in these qoliqoli areas from 2009 2015.
- 30/2017 Hon. Jiosefa Dulakiverata to ask the Minister for Industry, Trade, Tourism, Lands and Mineral Resources – Can the Minister provide the formula calculation for fair share of Royalty paid to landowners for the last 4 years as mentioned in section 30(1) of the Constitution.
- 31/2017 Hon. Viliame Gavoka to ask the Minister for Industry, Trade, Tourism, Lands and Mineral Resources – Can the Minister outline the formula with which compensation is calculated for those in the Yatu Malolo, who during filming of a movie or documentary, (which can run into months), are denied access to the "no go areas" established by the filmmakers; areas which in their normal daily lives are –
 - Routes of travel by sea;
 - Routes of travel by land; and
 - Fishing grounds.
