- 144/2018 Hon. Netani Rika to ask the Minister for Local Government, Housing and Environment, Infrastructure and Transport – Can the Minister provide an update on the newly designed vessel built in Malaysia.
- 145/2018 Hon. Aseri Radrodro to ask the Minister for Local Government, Housing and Environment, Infrastructure and Transport – Can the Minister inform the House why hasn't Government considered purchasing a vessel for MSAF and equipping them to respond to emergencies like the recent beaching of the Spirit of Altruism off Qoma waters.
