# FIRST PARLIAMENT IN THE WORLD: SELF-ASSESSMENT ON THE SDGs

The Inter-Parliamentary Union (IPU) has congratulated the Fijian Parliament for being the first in the world to carry out a self-assessment exercise on the Sustainable Development Goals (SDGs) from October 2 to 6, this year.

In an official letter to the Speaker Hon. Dr Jiko Luveni. IPU's Secretary-General Martin Chungong stated that such an exercise showed the strong commitment and ownership of the Parliament of Fiji to dealing with SDGs and promoting their comprehensive inclusion in its work.

"Fiji is the first country in the world to undertake this exercise, aimed at helping Parliaments assess their capacity and readiness to engage in the SDGs implementation," Mr Chungong said in the letter,

Mr Chungong commended the Honorable Speaker's close involvement and engagement in such process that set a noble example for other Parliaments to follow suit.

Hon. Dr Luveni said she was proud that the Fiji Parliament was taking the lead in engaging with the SDGs.

"Parliament is doing its part to mainstream the SDGs into its work such as legislative scrutiny, civic education and capacity-building for MPs and the secretariat," she said.

"We recognise the importance of international cooperation and conferences to stay up-to-date on what's happening and to be part of the international network working on the SDGs,"

Meanwhile, Minister for Agriculture, Rural & Maritime Development and National Disaster Management, Hon. Inia Serviratu, while delivering a congratulatory statement from the IPU to some Members of Parliament (MPs) during a workshop on the Parliamentary Engagement with the 2030 Agenda and SDGs on October 2, stated that this was a milestone achievement.

Hon. Serviratu said: "The self-assessment that is being undertaken with the assisistan

-ce of the IPU may conclude with an action plan that will set out concrete activities and areas of engagement for the Parliament of Fiji and the IPU, and UNDP would be happy to support the implementation of this plan".

"Although Fiji joined the IPU recently, it has already taken the lead role on SDG issues ranging from gender equality to human rights."

UNDP Pacific Country Director and Head of Regional Policy and Programme, Mr Bakhodir Burkhanov acknowledged the Fijian Parliament for embracing the vision of development, equity and peace embodied in the SDGs.

### OPENING OF THE 2017-2018 PARLIAMENT SESSION

My Government's purpose is to continue to bring Fijl into the full mainstream of International best practices to ensure that our legislation encourages - and certainly does not inhibit - proper development and growth, and to provide a positive climate for business to grow and for individual Fijians to accumulate wealth.

These were the words of His Excellency, the President, Major-General (Ret'd) Jioji Konusi Konrote while opening the 2017-2018 Parliament session in September, this year.

"As we look forward to the leaislation that you will consider in this session of Parliament, It is also valuable to review what we have done - what you have done - for the Fijian people since the Constitution was adopted. We are here for one reason: to represent the Fijian people and to keep their interests always before us," he said.

"I am proud that we have now enjoyed eight consecutive years of economic growth, continuing the longest period of growth in Fiji's history. This is due to prudent economic management and sound macroeconomic policies."

"Our reputation among development partners and international financial institutions has never been stronger. These institutions

like to lend their support to countries with sound policies and systems in place, countries that are stable and responsible. We give them that assurance, and they are responding with assistance, partnership and financing.

"I am also proud that our economic expansion has been broad-based. Education, health and welfare benefits have been extended as never before. Government benefits have literally put more money in the hands of the lowest-income Fijians by reducing the number of things they once had to

The economy, the President said has been expanding in part because his Government has established sound policies and trusted the Fijian people to respond with energy and sound ideas - and they have done just that, from the largest corporations to the smallest micro enterprise.

"We are encouraging entrepreneurship at all levels in Fiji through the Small and Micro Business Grants, which is truly an investment in our people. It goes to show that when government has faith in the people, the people repay that faith. And when the people invest in their country, foreigners are never far behind," he said.

"A country has no greater asset for its future than its youth, and my Government has put a priority on giving every Fijian child and adult the opportunity for a solid education, one that will help each one become a responsible and productive citizen with the means to lead a happy and fulfilling life."

Engaging our leaders in the formulation of policies is vital for the purpose of building a better place for our future generations.

Speaker of the Fijian Parliament Hon. Dr Jiko Luveni made this statement while addressing more than 50 participants at the 2017 Commonwealth Parliamentary Association (CPA) Australia and Pacific Regional Conference in Sydney, Australia on October 27.

With the theme "Engagement of all stakeholders is the key in formulating Climate Change policies that are sound, pragmatic and methodical to make lives better", the regional conference featured participants from all Australian Parliaments, Bougainville, Cook Islands, Fiji, Nauru, Niue, Tuvalu,

Vanuatu, Samoa, Solomon Islands along with representatives from Pakistan and the Channel Islands, Guernsev and Jersev,

"We need to secure the support of all our leaders in the engagement strategies of policy formulations if we are to make our world a better place for our children," Hon. Dr Luveni said.

# FIJIAN PARLIAMENT TAKES CENTRE STAGE AT 137TH IPU GENERAL ASSEMBLY

The Fijian Parliament took centre stage at the 137th Inter-Parliamentary Union ('IPU') General Assembly held in St Petersburg, Russia in October this year.

Speaker Hon. Dr Jiko Luveni chaired plenary sessions where all national Parliaments converged to discuss key issues- one being titled 'Promoting cultural pluralism and peace through inter-faith and inter-ethnic dialogue. Hon. Dr Luveni said the Fijian Parliament recognised that cultural pluralism and peace were important conduits for the achieve- change,

ment of the 2030 Agenda for sustainable development.

She further added that the Fijian Parliament was adamant to continue to encourage legal, regulatory and policy frameworks that were inclusive and ensured that all citizens regardless of ethnicity, culture and religion were fully covered under the Bill of Rights of the Constitution and have equal access to the basic needs of life.

The Speaker, in her concluding remarks, reiterated that since Fiji stood on the constitutional foundation of an inclusive society, the Fijian Parliament would continue to complement the work of the existing institutions of democracy, in efforts to encourage dialogue, respect, and build capacities for co-operation towards harmony and peaceful co-existence.

In a separate side event, the Minister for Employment, Productivity and Industrial Relations Hon. Jone Usamate addressed the IPU Standing Committee on Sustainable Development, Finance and Trade which discussed a draft Outcome Statement on climate The key message from Hon. Usamate was that it "is time to bring the Paris Agreement to life and COP23 needed to ensure that commitments were made and kept".

Hon. Usamate further emphasised on the need to keep global temperature growth to 1.5 degrees celsius and the need for accessibility to funding assistance.

# CLIMATE CHANGE SENSITIVITIES CRUCIAL FOR PARLIAMENT

Dr Jiko Luveni, Fiji's Prime Minister and President of COP 23 Hon. Vorege Bainimarama at the Parliamentary Meeting on the occasion of the United Nations Climate Change Conference (COP 23).

Speaker of the Fijian Parliament Hon. Dr Jiko Luveni suggested that "the global actions for climate change should, with urgency, be translated to national legislations and policies and to have in place, a Climate Change Bill".

This was part of the suggestions raised by the Speaker in her speech during the IPU Parliamentary meeting on the occasion of the United Nations Climate Change Conference (COP 23) held at the University of Bonn on November 12.

To build the capacity of parliaments to address the issue of climate change through its processes, given that climate change affects the economy, the social sectors, security, the productive sectors and all development programmes, Speaker raised these suggestions which she hoped will provoke discussions to enhance inter-parliamentary cooperation to tackle climate issues.

"Members of parliament should be climate change literate to have a multiplying effect on the population and be influential in people's actions to significantly cut and mitigate greenhouse gas emissions."

'In formulating climate change policies, members of parliament to engage with leaders in public and private sectors with all other stakeholders particularly those that have experienced the effects of climate change."

"When scrutinizing Bills and Annual Reports, Standing Committee members should be climate change sensitive and report on how these Bills are affected by the effects of climate change, etc," Speaker said.

She also emphasized the importance of IPU organized forums which can establish mechanisms for strong and effective links between parliaments of developed countries and those in the developing or least developed part of the world.

"I believe inter-parliamentary cooperation can be enhanced to allow for greater knowledge-sharing among parliamentarians. Parliamentarians in the low-capacity countries can benefit from the experience and resources of their colleagues in the developed countries," Hon. Dr Luveni added.


