- Hon. Aseri Radrodro to ask the Minister for Infrastructure, Transport, Disaster Management and Meteorological Services Can the Minister provide an update on the implementation of the MOU signed between the Land Transport Authority (LTA) and Fiji Revenue and Customs Service (FRCS) in January 2020.
