# **A BILL**

FOR AN ACT TO APPROPRIATE A SUM OF THREE BILLION, ONE HUNDRED THIRTY SIX MILLION, SEVENTY FIVE THOUSAND, THREE HUNDRED FORTY FIVE DOLLARS FOR THE ORDINARY SERVICES OF GOVERNMENT FOR THE YEAR COMMENCING 1 AUGUST 2019 AND ENDING 31 JULY 2020

ENACTED by the Parliament of the Republic of Fiji—

Short title and commencement

- 1.—(1) This Act may be cited as the COVID-19 Response Bill 2020.
- (2) This Act comes into force on 28 March 2020.

## Appropriation of \$3,136,075,345

**2.** A sum of \$3,136,075,345 is to be issued from the Consolidated Fund or other funds of the State, and applied to the ordinary services of the Government for the year commencing 1 August 2019 and ending 31 July 2020, and such sum is to be appropriated for the purposes specified in schedules 1 and 2 and also the COVID-19 Response Budget Estimates 2019-2020.

# Government borrowing

**3.** The Government borrowing for 2019-2020 must not exceed the sum of \$1,506,957,323.36.

# Repeal

**4.** The 2019-2020 Appropriation Act 2019 is repealed.

# **COVID-19 RESPONSE BILL 2020**

### **EXPLANATORY NOTE**

(This note is not part of the Bill and is intended only to indicate its general effect)

### 1.0 BACKGROUND

1.1 The COVID-19 Response Bill 2020 ('Bill') seeks to make provision for the estimate of capital and current expenditure for the ordinary services of the Government for the year 2019-2020.

#### 2.0 CLAUSES

- 2.1 Clause 1 of the Bill provides for the short title and commencement. If passed by Parliament, the Act will come into force on 28 March 2020.
- 2.2 Clause 2 of the Bill appropriates the sum of \$3,136,075,345 for the ordinary services of Government for the year commencing 1 August 2019 and ending 31 July 2020.
- 2.3 Clause 3 of the Bill provides that the Government borrowing for 2019-2020 must not exceed the sum of \$1,506,957,323.36.
- 2.4 Clause 4 of the Bill repeals the 2019-2020 Appropriation Act 2019.

### 3.0 MINISTERIAL RESPONSIBILITY

3.1 The Act comes under the responsibility of the Minister responsible for finance.
