## **A BILL**

FOR AN ACT TO APPROPRIATE A SUM OF THREE BILLION, TWO HUNDRED AND ELEVEN MILLION, NINETEEN THOUSAND, ONE HUNDRED AND TWENTY ONE DOLLARS FOR THE ORDINARY SERVICES OF GOVERNMENT FOR THE YEAR ENDING 31 JULY 2021

ENACTED by the Parliament of the Republic of Fiji—

Short title and commencement

- 1.—(1) This Act may be cited as the 2020-2021 Appropriation Act 2020.
- (2) This Act comes into force on 1 August 2020.

Appropriation of \$3,211,019,121

**2.** A sum of \$3,211,019,121 is to be issued from the Consolidated Fund or other funds of the State, and applied to the ordinary services of the Government for the year ending 31 July 2021, and such sum is to be appropriated for the purposes specified in schedules 1 and 2 and also the 2020-2021 Budget Estimates.

Government borrowing

3. The Government borrowing for 2020-2021 must not exceed the sum of \$2,750,529.30.

# 2020-2021 APPROPRIATION BILL 2020

#### **EXPLANATORY NOTE**

(This note is not part of the Bill and is only intended to indicate its general effect)

#### 1.0 BACKGROUND

1.1 The 2020-2021 Appropriation Bill 2020 (**'Bill'**) makes provision for the estimate of capital and current expenditure for the ordinary services of the Government for the year 2020-2021.

#### 2.0 CLAUSES

- 2.1 Clause 1 of the Bill provides for the short title and commencement. If passed by Parliament, the legislation will come into force in the new financial year on 1 August 2020.
- 2.2 Clause 2 of the Bill appropriates the sum of \$3,211,019,121 for the ordinary services of the Government for the financial year ending 31 July 2021 for the purposes specified in schedules 1 and 2 to the Bill and the 2020-2021 Budget Estimates.
- 2.3 Clause 3 of the Bill provides that the Government borrowing for 2020-2021 must not exceed the sum of \$2,750,529.30.

#### 3.0 MINISTERIAL RESPONSIBILITY

3.1 The Act comes under the responsibility of the Minister responsible for finance.
