### 1. Hon. Viam Pillay to move –

#### **Oral Questions**

- 127/2020 Hon. Lenora Qereqeretabua to ask the Minister for Commerce, Trade, Tourism and Transport Can the Minister inform Parliament why heavy-goods trucks carting construction and infrastructure development raw materials such as quarry stones are allowed to pass through the densely populated residential subdivision of Tavakubu in Lautoka instead of using the designated alternate route of Natabua road.
- 128/2020 Hon. Joseph Nand to ask the Minister for Forestry Can the Minister update Parliament on the progress of the National Tree Planting initiative.
- Hon. Anare Jale to ask the Minister for Defence, National Security and Policing, Rural and Maritime Development and Disaster Management With urban drift affecting all 14 Provinces particularly the Maritime Provinces like Lau, can the Minister inform Parliament what policies are in place to reduce urban drift.

Rohit Sharma to ask the Minister for Infrastructure, Meteorological Services, Lands and Mineral Resources Can the Minister enlighten Parliament on the importance of VSAT Stations and tsunami sirens and if the Ministry has any other techniques to detect or prepare the public for seismic occurrence.

Ro Filipe Tuisawau to ask the Attorney-General and Minister for Economy, Civil Service and Communications Can the Minister inform Parliament what assistance is given to businesses who have either been forced to reduce working hours of their staff or reduce opening hours due to the economic downturn caused by the COVID-19 pandemic.
