The Attorney-General and Minister for Economy, Civil Service and Communications the Hon. Aiyaz Sayed-Khaiyum moved a motion pursuant to the resolution of Parliament on Wednesday, 9th December 2020 that the COVID-19 Response (Home Loan Assistance) Bill 2020 be debated, voted upon and be passed.

A Bill for an Act to provide for home loan assistance for the payment of mortgage monies and for related matters (Bill No. 43 of 2020), enacted by the Parliament of the Republic of Fiji.

17. CUSTOMS TARIFF (AMENDMENT) (NO. 3) BILL 2020

The Attorney-General and Minister for Economy, Civil Service and Communications the Hon. Aiyaz Sayed-Khaiyum moved a motion pursuant to the resolution of Parliament on Wednesday, 9th December 2020 that the Customs Tariff (Amendment) (No. 3) Bill 2020 be debated, voted upon and be passed. Motion seconded.

Motion agreed to unanimously.

A Bill for an Act to amend the Customs Tariff Act 1986 (Bill No. 44 of 2020), enacted by the Parliament of the Republic of Fiji.
