RECOMMENDATION

The Standing Committee on Natural Resources has conducted a review of the Ministry of Lands & Mineral Resources (MLMR) Consolidated Annual Reports for 2011, 2012 and 2013 and recommends that Parliament take note of its report.

1.0 INTRODUCTION

The Ministry of Lands and Mineral Resources Annual Reports 2011.2012 and 2013 was tabled in Parliament during the 31st August, 2020 Parliament sitting and referred to the Standing Committee on Natural Resources for scrutiny.

The Committee proceeded with its mandatory function legislated under Standing Order 109(2) (c) which allows the Standing Committee on Natural Resources to examine matters related to forestry, agriculture, mining, environment, fisheries, water and marine services.

Standing Orders 110(1)(c) further authorizes the Standing Committee to *scrutinize the government departments with responsibility within the committee's subject area, including by investigating, inquiring into, and making recommendations relating to any aspect of such a department's administration, legislation or proposed legislative program, budget, rationalization, restructuring, functioning, organization, structure and policy formulation.*

A Standing Committee must report to Parliament any other matter referred to or initiated by the Committee, as soon as it has completed its considerations and deliberations as stipulated under SO 121 (1) (b).

1.1 PROCEDURE AND PROGRAM

The Committee proceeded with its scrutiny and formulated questions which were sent to MLMR to respond to. The questions were basically on the challenges faced by the Ministry during the period under review, achievements, operational review, legislations in place, progress on the Ministry's initiatives. The Ministry's responses were received by the members and was incorporated into the Committees report for final presentation to parliament.

2.0 ABOUT THE MINISTRY OF LANDS & MINERAL RESOURCES IN 2011, 2012 & 2013

The Ministry of Lands & Mineral Resources is made up of two Departments, namely the Department of Lands & Survey and the Department of Mineral Resources.

The Department of Lands and Survey is responsible for the administration, development and management of all State land activities. Functions and responsibilities of the department are further categorized into:

- State Land Management Division
- Land Use Unit
- Land Survey Division
- Land Valuation Division
- Corporate Services Division

The Department of Mineral Resources oversees and facilitates development of the country's mineral and ground water resources. The department has four divisions which constitutes the overall mining and groundwater resources. These are namely:

- Geological Services Division
- Geological Survey & Information Division
- Mining Division

One of the achievements and major highlights of the Ministry of Lands and Mineral Resources in 2011 was the opening of the Nawailevu Bauxite in Bua and the signing of the Vatukoula Social Assistance Trust Fund as reflected in the 2011 annual report.

It was also noted that the Lands Administration Division managed to surpass its annual target of 3500 by processing 4681 legal documents which was in line with the Ministry's ACP targets for 2013. Also the Ministry developed a draft SOP for Lands Administration during the stated year.

3.0 COMMITTEE'S RECOMMENDATIONS

1. RECOMMENDATION

To safeguard public interests from unscrupulous land dealers, MLMR may consider publicizing Bi-Annually trends or averages of Values of major land uses (Commercial, Industrial, Residential and Agriculture) to start with, for their information for level of value that they should be expecting. It will give the public some information and confidence for selling or buying. Private Valuers still provide professional services to their clients whether buyers and sellers, financiers, and any other entity to meet their own requirements on value. It would be a service MLMR can provide through the Valuation Department which would be well appreciated by the members of the public at large.

2. RECOMMENDATION

The Committee recommends proper editing of future annual reports by staff before submitting to parliament for further scrutiny. For example:

(1)The Ministry to include output 13 on page 6 on KOA or to appear as output 5 on page 18.

(2) 2012 annual report Page 30 – whereby item k Note 3 appears after Note 4, and item g Note 3 to be shifted left under item f.

3. RECOMMENDATION

The Ministry continued to be challenged by outdated processes and the committee recommends that it should review and update in order to improve its services to be able to meet the demands of its clients.

4. **RECOMMENDATION**

The Committee strongly recommends that future annual reports of the Ministry of Lands & Mineral Resources be submitted in a timely manner.

4.0 SUSTAINABLE DEVELOPMENT GOALS (SDGs)

4.1 GENDER EQUALITY ANALYSIS – SDG 5

The Committee noted that there was no information on Gender provided in the annual reports for the period under review.

5.0 CONCLUSION

The overall performance of the Ministry of Lands and Mineral Resources for the period under review was satisfactory.

However, the Committee is hopeful that in future the Ministry will submit its annual report to Parliament in a timely manner.
