- 192/2021 Hon. Alexander O’Connor to ask the Attorney-General and Minister for Economy, Civil Service, Communications, Housing and Community Development – Can the Minister update Parliament on why were the 2019-2020 Household and Income Expenditure Survey results released in August this year flawed.
- 193/2021 Hon. Anare Jale to ask the Minister for Commerce, Trade, Tourism and Transport – Can the Minister update Parliament on the assistance provided to people in maritime provinces who depend on tourists to purchase their handicrafts.
- 194/2021 Hon. Alipate Nagata to ask the Minister for Defence, National Security and Policing, Rural and Maritime Development and Disaster Management – The Ministry of Rural and Maritime Development has been allocated a sum of \$500,000 for Water and Sanitation in the current budget. Can the Minister inform Parliament how the Ministry intends to utilise this allocation in this financial year.
