

PARLIAMENT OF THE REPUBLIC OF FIJI

MINUTES

of Proceedings of Parliament at Suva on Monday, Twentieth Day of September, 2021

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.

3. <u>MEMBERS PRESENT</u>

All Honourable Members were present.

4. CONFIRMATION OF MINUTES

Hon. Speaker welcomed all Honourable Members to the sitting of Parliament and all those watching the live broadcast and the live-streaming of the proceedings.

- 191/2021 Hon. Lenora Qereqeretabua asked the Minister for Health and Medical Services Can the Minister inform Parliament why there is no laboratory Technician at the Levuka Hospital for at least two months.
- Hon. Alexander O'Connor asked the Attorney-General and Minister for Economy, Civil Service, Communications, Housing and Community Development Can the Minister update Parliament on why were the 2019-2020 Household and Income Expenditure Survey results released in August this year flawed.
- Hon. Anare Jale asked the Minister for Commerce, Trade, Tourism and Transport Can the Minister update Parliament on the assistance provided to people in maritime provinces who depend on tourists to purchase their handicrafts.
- Hon. Alipate Nagata asked the Minister for Defence, National Security and Policing, Rural and Maritime Development and Disaster Management The Ministry of Rural and Maritime Development has been allocated a sum of \$500,000 for Water and Sanitation in the current budget. Can the Minister inform Parliament how the Ministry intends to utilise this allocation in this financial year.
- Hon. Adi Litia Qionibaravi asked the Prime Minister and Minister for iTaukei Affairs, Sugar Industry, Foreign Affairs and Forestry Can the Prime Minister inform Parliament on the Ministry's programme and initiatives to encourage the learning and transfer of indigenous ecological knowledge and environmental management.

- Hon. Vijay Nath asked the Minister for Health and Medical Services Can the Minister inform Parliament if there are plans to allow Private General Practitioners to administer COVID-19 vaccines to members of the public.
- Hon. Salote Radrodro asked the Minister for Women, Children and Poverty Alleviation Can the Minister update Parliament on the Monitoring and Evaluation mechanism in place to monitor the impact of the Ministry's Elimination of Violence Against Women programmes.
- Hon. Veena Bhatnagar asked the Minister for Defence, National Security and Policing, Rural and Maritime Development and Disaster Management Can the Minister inform Parliament what the Fiji Police Force will do to address complaints against Police and police services.

Written Question

- 199/2021 Hon. Ro Teimumu Kepa asked the Minister for Agriculture, Waterways and Environment Can the Minister update Parliament on the progress in the implementation of the Naboro landfill upgrade, in particular
 - (a) progress made in 2018-2019 and 2019-2020 on the construction of stage 2 of the landfill; and
 - (b) progress made in 2020-2021 for stage 2 cell 3 of the landfill and plans for completion of this stage in the 2021-2022 financial year.
