Executive Chairman's Report



I am pleased to present the Fiji National Sports Commission Annual Report for the August 2019 – July 2020 Financial Year, which has been possibly one of the most difficult years we have faced; the year of the pandemic, the year of COVID-19.

While the first quarter of the period under review began with the usual focus on our core activities of developing sports programs for the upcoming year, we had to rethink some of our strategies with the measles outbreak that began in the first week of November 2019. This directly impacted the facilitation of programs, especially activities for children, planned to take place in the vicinity of affected villages and communities.

With two sports teams being diagnosed with measles, regrettably our National Football Team was quarantined in New Caledonia and the Tongan Women's team attending the Oceania Rugby event was quarantined in Nadi. We very quickly learnt the cost and logistics involved in athletes being quarantined and this was pre-Covid.

Strengthened relationship

The close cross-sectoral professional relationship that we have always enjoyed with the Ministry of Health and Medical Services (MoH&MS) was strengthened during this time. As the Ministry worked tirelessly to contain and halt the measles outbreak, the Commission ensured that proper protocols were in place and being adhered to, in order to protect the health and well-being of our staff, the National Sporting Organizations (NSOs) and, most importantly, the people of Fiji.

As we entered the 2020 calendar year, we became aware of reports that a new strain of coronavirus, COVID-19 had broken out in Wuhan, China. The Sports Commission responded by quickly formulating and initiating risk management policies, as well as establishing plans for recovery into the future.

The information about the deadly and fast-spreading virus coincided with our annual conference, held on 7th March, 2020, to which we

invited the Permanent Secretary of Health to address all stakeholders in attendance about the difficult times we could expect to face.

The following week, Fiji experienced its first case and the nation went into lockdown.

Immediate response

The immediate consequences included asking our staff to work from home; the cancellation of sports development programs for the well-being of staff and communities; the reduction of funding for hosting of international events, which were cancelled or postponed indefinitely; the closing of gyms, and training programs on hold, with athletes following their individual training programs.

I am pleased to report that as we faced the uncertainties of the changing sporting landscape unfolding before us, we were able to meet these challenges by being adaptive, proactive, and by working collaboratively with stakeholders across all relevant sectors.

Staff worked from home and developed reports that addressed gaps identified during training. This produced excellent material on topics such as the Effect of Internal Politics on Sports, and Community Challenges faced by Women Participating in Sports. These reports are being incorporated into the development of our new programs.

Safe Sports Fiji Guidelines

The Sports Commission advised all National Sporting Organizations of the necessity to have their sport certified under the Safe Sports Fiji Guidelines, developed by the Commission and accepted globally, to show that Fiji's sports people were working within the guidelines of their own sport and adhering to the necessary restrictions.

The guidelines were formulated by a committee established for this purpose, with professional representation from the medical and physiotherapy, legal, athletic and sporting sectors. The guidelines include 50 per cent attendance in stadiums, social distancing, contact tracing, hygiene practices such as hand washing and the use of hand sanitizers. These guidelines are still in place.

The first response to the certification requirement was substantial, with 11 sporting associations out of 45 being certified within the first three weeks, with rugby, football and rugby league amongst the first to start playing again.

This was one of our most important achievements towards the second half of the fiscal year; working within the required restrictions but still finding a way to safely facilitate sports.

Positive outcomes

In challenging times, there are always the positive and unexpected outcomes. We have initiated new and more economically efficient practices, such as using Zoom for in-house training, so training can be conducted weekly or monthly, rather than every two or three months. Many sporting organizations have followed this example and are also running their training programs on-line.



The adverse circumstances have made us closer with our international neighbors. As one of the first countries in the region to have Safe Sport Guidelines in place, we have been able to provide a leading example of what was required.

The sporting community has become closer as a common threat has united us all. COVID-19 has meant that what we may have lost at the elite level of sport, we are making gains at the developmental level. Our increased focus on more communal sporting events is expected to lead to a new group of talented athletes being identified.

Of course, as we have restarted community programs, there are new protocols in place that must be observed. At all of our programs, we provide hand sanitizers, water, and temperature gauges, as all attendees must have their temperature taken. Social distancing and contact tracing are prerequisites for attending all programs.

Strategic Plan 2019-2023

We also responded to the changes imposed by the pandemic by reviewing the FNSC 2019-2023 Strategic Plan, with the Commission's Four Pillars remaining unchanged. The Four Pillars - Health & Active Nation, Sporting Nation, Enabling Environment, and Enriching Nation - are aligned with the goals of the Government's National Development Plan and the United Nations Sustainable Development Goals.

I wish to thank the staff of the Sports Commission. Your commitment and hard work has been exemplary, despite the unusual and testing circumstances we have faced.

Acknowledgements

I wish to take this opportunity to thank the Minister of Youth & Sports, and our line Ministry, as well as the Ministry of Economy for their continued support. It is customary to congratulate Government for their funding allocations in support of our work with developing sports and athletes across all abilities and age groups. This financial year, we are thanking Government and supporting the country during this pandemic by returning funding, as we are not able to use it for the allocated purposes.

I would like to acknowledge the ongoing support of my Board of Directors, whose contribution has been invaluable, particularly through these most challenging of times.



OSEP Tracer Study Follow Up Report

Fiji National Sports Commission is a Training Provider for the Oceania Sports Education Program (OSEP) which is managed by the Oceania Olympic Committee (ONOC) The commission currently runs community level courses from this program to help enhance the community sports structures that are being set up. The survey was facilitated by the OSEP Team on a sample 309 participants out of 774 participants trained Fiji-wide 2017-2019.

The survey was conducted in the following centers.

- 1. Vunisea, Kadayu
- 2. Levuka, Lomaiviti
- 3. Gau. Lomaiviti
- 4. Suva
- 5. Namosi
- 6. Serua
- 7. Naitasiri

Key finding of Survey

- 11 provinces in Fiji were covered during the survey.
- There has been a widespread establishment of community sports associations and clubs.
- Strong collaboration by FNSC for joint sport for development initiatives in the communities
- The programs had contributed significantly to the development of community level sports.
- The study reaffirmed that training and development is the main factor that leads to progress and performance in participants, community sports and national federations.

Recommendations

- Keep improving delivery skills of trainers for effective results Review strategy - Strengthen joint outreach with NSO's like integrating OSEP coaching course and sport examples when running coaching courses, introduce the next tier of OSEP competition level courses, host women only courses in coaching and leadership.
- Develop a workforce strategy to strengthen skills of OSEP trainers for continuous improvement and graduation into a Master Educator, Regional Master Educator and Mentor status.
- Program management Develop strategy leading to the Fiji
 National Games, a monitoring and evaluation plan for all FNSC
 Education programs so that all its programs, outcomes achieved
 and impact are aligned and consolidated. The next tracer to
 consolidate all programs and measure the overall impact in the
 community.



Fiji National Annual National Sporting Organization Conference March 2020

The 2020 Annual National Sporting Organization Conference was held on 7th March, 2020 at the Grand Pacific Hotel in Suva. There were representatives from 42 National Sporting Organizations, 15 Community Sports Associations, Ministry of Youth & Sports, FASANOC, Think Pacific, Fiji Sports Council, Ministry of Education, Ministry of Health & Medical Services and Ministry of Local Government.

We had a total of 151 register on the day of the conference: 85 NSO representatives; 17 Community Sports Association representatives; 17 representatives from Ministry of Youth & Sports; FASANOC; Think Pacific, and Fiji Sports Council. We had expected 17 speakers, with one unable to travel last minute due to COVID-19 restrictions, two Board members and 15 Staff. We had two Walk-in Representatives, one each from the Ministry of Health & Medical Services and the Ministry of Education, one being a speaker and the other, to observe.

The theme for the Conference was "Planning for the Future", with 4 thematic areas which were, Integrity of Sports, 4 Year Development Plan, Funding and Sponsorships, Physical Education and Pathways for Sports and Contribution of Facilities Development towards Sports Progress.

INDEPENDENT AUDITOR'S REPORT

To the Members of Fiji National Sports Commission

Report on the Audit of the Financial Statements

Opinion

I have audited the financial statements of Fiji National Sports Commission ("the Commission"), which comprise the statement of financial position as at 31 July 2020, and the statement of comprehensive income, statement of changes in equity and statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In my opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Fiji National Sports Commission as at 31 July 2020, and of its financial performance and its cash flows for the year then ended in accordance with International Financial Reporting Standard for Small and Medium-sized Entities (IFRS for SMEs).

The impact of COVID-19 pandemic resulted in major reduction to grant funding in the new financial year 2021 and all capital purchases and replacement of disposed assets have been postponed. Only the international coaches grant and sports development programs were in continuation.

Responsibilities of the management and those charged with governance for financial statements

The management and Commissioners are responsible for the preparation and fair presentation of the financial statements in accordance with IFRS for SMEs, and for such internal control as the management and Commissioners determine is necessary to enable the



preparation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTES TO AND FORMING PART OF THE FINANCIAL STATEMENTS FOR THE FINANCIAL YEAR ENDED 31 JULY 2020

1. General Information

Fiji National Sports Commission ("the Commission") is a body corporate incorporated under Fiji National Sports Commission Act No. 5 of 2013 and domiciled in Fiji. The address of the Commission's registered office is 220 Laucala Bay Road, Suva, Fiji Islands. The Commission is primarily involved in the promotion and development of sports in Fiji.

The financial statements were authorised for issue with a resolution of the members of the Commission on 1 FEB. 2021.

The significant accounting policies which have been adopted in the preparation of these financials statements are:

2. BASIS OF PREPARATION

(a) Statement of compliance

The financial statements of the Commission has been prepared in accordance with International Financial Reporting Standards for Small and Medium-sized Entities ('IFRS for SMEs').

(b) Basis of measurement

The financial statements have been prepared on the historical cost basis and do not take into account of changing money values or except, where stated, current valuations of non-current assets.

(c) Functional and presentation currency

These financial statements are presented in Fijian currency, which is the Commission's functional currency. All financial information presented in Fijian currency has been rounded to the nearest dollar.

(d) Use of estimates and judgments

The preparation of the financial statements in conformity with IFRS for SMEs, management of the Commission is required to make judgments, estimates and assumptions that affect the application policies and the reported amounts of assets, liabilities, income and expense. Actual results may differ from these estimates. Estimates and underlying assumptions are reviewed on an on-going basis.

Revisions to accounting estimates are recognized in the period in which estimates are revised and in any future periods affected.

Judgments made by management in the application of IFRS for SMEs that have significant effects on the financial statements and estimates are disclosed, where applicable, in the relevant notes to the financial statements.

Accounting policies are selected and applied in a manner which ensures that the resulting financial information satisfies the concepts of relevance and reliability, thereby ensuring that the substance of the underlying transactions or other events is reported.



3. SIGNIFICANT ACCOUNTING POLICIES

The accounting policies set out below have been applied consistently to all periods presented in these financial statements, and have been applied consistently by the Commission.

(a) Cash and cash equivalents

Cash and cash equivalents are carried in the balance sheet at cost. For the purpose cash flow statement, cash and cash equivalents comprise cash on hand and cash at bank.

(b) Foreign currency

Foreign currency transactions are translated to Fijian currency at rates of exchange ruling at the dates of the transactions. Amounts receivable and payable in foreign currencies are converted to Fijian currency at the rates of exchange ruling at balance date. All exchange gains or losses whether unrealized are included in the income statement.

(c) Deferred income

Government grant in aid and assets acquired at no cost to the Commission are capitalised and systematically recognised as other income on the basis of the expected lives of the assets to which the grant relates.

Grants received before the revenue recognition criteria are satisfied, are recognised as a liability.

(d) Government grant

The Commission receives operating grant from the Government. Operating grants that compensate the Commission for expenses incurred are recognised as revenue in the income statement on a systematic basis in the same period in which the expenses are incurred. Operating grants that are used to compensate the cost of an asset are recognised in the income statement as revenue on a systematic basis over the useful life of the assets.

The Commission also receives sporting grant from the Government. The sporting grants are disbursed by the Commission to various sporting organisation and agency for overseas tours, sports scholarships, and engagement of short term experts and hosting of international tournaments.

Furthermore, the Commission receives international coaches grant from the Government which is utilised to pay the salary and other benefits for the full time international engaged by various sporting organisation.

The Commission also receives United Nations Office on Sport for Development and Peace grant (UNOSDP) funded by the Ministry of Foreign Affairs of the Republic of Korea given on the existence for the development of a Manual which would assist in the facilitation of physical activities for our disabled and special needs person in Special Schools and Inclusive mainstream schools. This would create sporting participation opportunities for children with special needs in a FUN, SAFE and CREATIVE environment; provide children with life skills through sport participation and to develop and expand parents, coaches and administrators' understanding of the educational value of sport. The Manual has been completed and distributed to all disabled and special needs schools in October 2019.

(e) Income tax

Income of the Commission is exempt from income tax in accordance with Section 17(24) of the Income Tax Act.



3. SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

(f) Sponsorship Equipment

Sponsorship equipment received from JR White started since the inception of FNSC in 2013. FNSC's strategic goals include the encouragement of physical activity through sports for the people of the nation. The purpose of donating sports equipment which is sponsored through JR White is to give communities the opportunity to learn, practice and enjoy physical activity on their own with access to proper sports equipment. The recipients of the sports equipment are village heads, clubs, schools and communities where FNSC carries out its Sports Outreach and Train the Trainer Programs. The donation is carried out by FNSC after the completion of a program in a community. FNSC usually take different types of sports to communities for the programs and donation is done once the sports and the basics of the sports are introduced to the communities. The Commission donate equipment for those sports for the people to carry on playing those sports. The equipment's is used by the members of the community such as the Women's club, Men's and children's club, schools, inclusive where a village representative signs the donation forms. The equipment is also used for community or clubs organized tournaments which usually FNSC is invited to be a part of.

(g) Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment loss. Cost includes expenditure that is directly attributable to the acquisition and installation of the items. Property, plant and equipment are depreciated on a straight-line basis over their estimated useful lives using the following rates:

Computer Equipment	20%
Furniture and Fittings	20%
Motor Vehicles	20%

Profits and losses on disposal of property, plant and equipment are taken into account in determining the results for the period.

(h) Employee entitlement

Annual leave

The liability for annual leave is recognized in the provision for employee entitlement. Liabilities for annual leave are expected to be settled within 12 months of the reporting date and are measured at their nominal values using the current remuneration rate which is expected to be applied at the time of settlement.

Long service leave

The Commission does not have any long service leave policy in place. All employee entitlement is expected to be used by employees within the fiscal year.

Wages and salaries

Liabilities for wages and salaries expected to be settled within 12 months of the reporting date are accrued up to the reporting date.

Defined contribution plans

Contributions to Fiji National Provident Fund (FNPF) by the Commission are expensed when incurred.

(i) Trade and other payables

Liabilities are recognized for amounts to be paid in the future for goods and services rendered. Creditors and accruals are stated at cost.



3. SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

(i) Leased assets

The determination of whether an arrangement is, or contains a lease is based on the substance of the arrangement at inception date of whether the fulfillment of the arrangement is dependent on the use of a specific asset or assets or the arrangement conveys a right to use the asset.

Finance leases, which transfer to the Commission substantially all the risks and benefits incidental to ownership of the leased item, are capitalized at the inception of the lease at the fair value of the leased property or, if lower, at the present value of the minimum lease payments. Lease payments are apportioned between the finance charges and reduction of the lease liability so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are reflected in income statement.

Subsequent to initial recognition, the asset is accounted for in accordance to the accounting policy applicable to that asset.

(j) Comparative

Where necessary, amounts relating to prior years have been re-classified to facilitate comparison and achieve consistency in disclosure with current financial year amounts.

(k) Value Added Tax (VAT)

All the revenue, expenses, assets and liabilities are recorded at VAT inclusive prices. This treatment is based on the advice provided by Fiji Revenue Customs Services on 31 January 2014. The reasons are as follows:

The Commission is basically providing funding and development of sports in Fiji and this is done through government grant funding. With such set up and with no taxable/business activities, the Commission is not registered for VAT. Any expenses incurred for which the Commission is charged VAT, the VAT portion will be cost to the Commission.

In consideration of the ongoing COVID-19 pandemic, all capital purchases have been postponed. Replacement of disposed assets will happen once operations are back to normal. As such, the Commission on balance date 31/07/2020, approved the valuation of four of its motor vehicle that had zero Written down Value (WDV). The valuation was done by the dealers namely ASCO Motors and Carpenters Motors. 19. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The Commission's activities expose it to financial risks. The Commission is basically providing funding to National Sporting Bodies for the development of sports in Fiji and this is done through government grant received. The operation of the Fiji National Sports Commission depends on the grants received from the Government.

The Commission is exposed to credit risk. The Commission entered into a finance lease agreement with Australian and New Zealand Banking Group Limited. Even though these obligations are not recognized on the statement of financial position, they do contain credit risk and are therefore part of the overall risk of the Commission.

Risk is inherent in the Commission's activities but it is managed through a process of ongoing identification, measurement and monitoring, subject to risk limits and other controls. The independent risk control process does not include business risks such as changes in the environment, technology and industry. They are monitored through the Commission's strategic planning process.

(a) Market risk

Market risk does not apply to the Commission since it is not involved in trading activities.

(i). Political climate

The Commission operates in Fiji and changes to governments, policies affect economic situation and ultimately the grant income of the Commission.

(ii) Interest rate risk

At the reporting date the Commission did not have any interest-bearing financial instruments.

20. SIGNIFICANT EVENTS DURING THE YEAR

The COVID-19 pandemic had substantial effect on the programs and grants of Fiji National Sports Commission. Due to COVID-19 the utilization of Sports grant \$917,083, International Coaches grant \$126,214 and UNOSDP grant of \$26,722 were deferred.

The restriction on overseas travel and limited number of people allowed to gather led to cancellations and/or postponements to most grant utilization. The overseas sports tour grant for preparation and participation of Tokyo Olympics was deferred pending confirmation on the new date of event.

21. EVENTS SUBSEQUENT TO BALANCE DATE

The COVID-19 pandemic and the unprecedented uncertainty in the sporting and economic environment continues post year. The impact of COVID-19 pandemic resulted in major reduction to grant funding in the new Financial Year 2021 and all capital purchases and replacement of disposed assets have been postponed. Only the international coaches grant and sports development programs were in continuation.

In the event that the COVID-19 pandemic impact is prolonged than anticipated, this may result in the further reduction of the grant funding in the subsequent financial year.



22. PRINCIPAL ACTIVITIES

The principal activity of the Commission is to guide and enhance the delivery of sports programmes in Fiji through a coordinated approach at all levels of participation by government statutory bodies and the community and to ensure the development of sports in Fiji. The Commission was established under the Fiji National Sports Commission Act No. 5 of 2013.
