# **MINUTES**

#### of Proceedings of Parliament at Suva on Wednesday, First day of December, 2021

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.

#### 4. <u>CONFIRMATION OF MINUTES</u>

The Leader of the Government in Parliament the Hon. Inia Seruiratu, moved that the Minutes of the sitting of Parliament held on Tuesday, 30 November 2021, as previously circulated be taken as read and be confirmed.

#### 5. <u>COMMUNICATIONS FROM THE CHAIR</u>

Hon. Speaker welcomed all Honourable Members to the sitting of Parliament. He also welcomed all those watching the live broadcast and the live-streaming of the proceedings from home, offices and electronic gadgets.

Hon. Speaker informed the Honourable Members that 1<sup>st</sup> December is World Aids Day and a day to remember the millions of people who had lost their lives to AIDS-related illnesses as the disease has been around for 40 years and continues to threaten the lives of many around the world.

Hon. Speaker also informed Honourable Members that as part of Parliament's health awareness initiatives, a team from Diabetes Fiji would be in Parliament to share more information about diabetes and they were accompanied by a team from the Ministry of Health and Medical Services to offer NCD screening for Members as well as booster shots for COVID-19.
