A BILL

FOR AN ACT TO APPROPRIATE A SUM OF FOUR BILLION, TWO HUNDRED AND FORTY NINE MILLION, TWENTY NINE THOUSAND TWO HUNDRED AND NINETY EIGHT DOLLARS FOR THE ORDINARY SERVICES OF GOVERNMENT FOR THE YEAR ENDING 31 JULY 2019

ENACTED by the Parliament of the Republic of Fiji—

Short title and commencement

- 1.—(1) This Act may be cited as the 2018-2019 Appropriation Act 2018.
- (2) This Act comes into force on 1 August 2018.

Appropriation of \$4,249,029,298

2. A sum of \$4,249,029,298 is to be issued from the Consolidated Fund or other funds of the State, and applied to the ordinary services of the Government for the year ending 31 July 2019, and such sum is to be appropriated for the purposes specified in Schedules 1 and 2 and also the 2018-2019 Budget Estimates.

Government borrowing

3. The Government borrowing for 2018-2019 shall not exceed the sum of \$708,490,390.60.

2018-2019 APPROPRIATION BILL 2018

EXPLANATORY NOTE

(This note is not part of the Bill and is intended only to indicate its general effect)

1.0 BACKGROUND

- 1.1 The 2018-2019 Appropriation Bill 2018 (**‘Bill’**) makes provision for the estimate of capital and current expenditure for the ordinary services of the Government for the year 2018-2019.

2.0 CLAUSES

- 2.1 Clause 1 of the Bill provides for the short title and commencement. If passed by Parliament, the legislation will come into force in the new financial year on 1 August 2018.
- 2.2 Clause 2 of the Bill appropriates the sum of \$4,249,029,298 for the ordinary services of the Government for the financial year ending 31 July 2019 for the purposes specified in Schedules 1 and 2 to the Bill and the 2018-2019 Budget Estimates.
- 2.3 Clause 3 of the Bill provides that the Government borrowing for 2018-2019 must not exceed the sum of \$708,490,390.60.

3.0 MINISTERIAL RESPONSIBILITY

- 3.1 The Act comes under the responsibility of the Minister responsible for finance.
