# January - July at a Glance

## **Sports Grants**

The U19 Cricket Team participated in the ICC U19 Cricket World Cup, held in Bangladesh.

FASANOC - Team Fiji preparation for 2016 Olympaics in Rio de Janeiro, Brazil, took place.

Fiji participated in the World Youth Weightlifting Championships.

Fiji hosted the Melanesian Regional Athletics CF ampionship, the Oceania Swimming Championship, the Oceania Volleyball Tournament, the Oceania Weightlifting Championship and the Tennis Fiji Open Tournament.



## **Sports Development Unit**

All staff participated in delivering relief supplies to victims of T.C. Winston.

A single Sports Outreach Programme was conducted in Saqani, Cakaudrove, where the Fitness Leader Concept was implemented for the first time, to the 103 participants.

Three Train the Trainer Programmes were conducted, one each in Labasa, Lautoka and Sigatoka.

66 coaches accredited in volleyball, rugby union, and rugby league, and certified as fitness leaders and sports administrators through the OSEP SIC Course.

2208 students from 16 schools on Ovalau and in Naitasisri and Labasa were engaged in the Kids in Community Programme. A total of 2208 were engaged in the programme. The schools were from Naitasiri, Ovalau, and Labasa.

2669 participants took part in the Wellness.

685 participants benefited from the Commission's Community Assistance initiatives.

Staff training included:

- Table Tennis Level 1 Accreditation Course;
- Just Play Accreditation Course;
- Fiji Football Referee's Workshop;
- Tennis Australia Tennis Hot Shots Programme and
- OSEP Regional Leadership Workshop for Master Educators.



# Executive Chairman's Report



The Fiji National Sports Commission has followed Government's initiative with the change in the fiscal year to finish on 31st July. Hence I am now pleased to present our Annual Report for the seven month period, being 1 January 2016 – 31 July 2016.

I acknowledge the support of my Board, the Minister of Youth and Sports, our line Ministry and the Minister of Economy for our funding assistance.

A special thanks goes to my staff who, during these difficult and challenging seven months, truly showed their best.

The Commission has continued its commitment, not just to sports development, but also to bringing physical activity to all communities, helping to enhance the health and wellbeing of the Nation.

New community programmes have been introduced with the establishment and promotion of "Fitness Leaders", thus enabling all Fijians, no matter what their age, to partake in physical activity on a regular basis.

## 2016 Challenges

Planning for the Commission in 2016 was all ready to proceed, with our first Rural Sports Outreach programmes ready to commence in Ra during February, when Cyclone Winstone descended on the country, leaving a destructive path.

This saw all sectors of society disregarding any plans they had in place for the new year and responding immediately to the humanitarian crisis the cyclone left in its wake. The Commission was no different and I was extremely proud at how quickly all the Commission staff reacted.

Commission staff and vehicles immediately moved to divisional relief operations, working night and day, assisting with the distribution of essential supplies such as food, water and tents, to those most in need in Tailevu, Ra, Ba, Lautoka and Labasa. This commitment to bringing relief to cyclone victims continued until April.

## **A New Direction**

Sports Development Programmes were no longer a priority as many of the villages and areas where we had planned to conduct programmes were damaged or destroyed.

To enable the youth of these villages to have a break from their difficult circumstances, we arranged to host them at weeklong sports development camps in the towns of Lautoka, Sigatoka and Labasa. We brought them in from their rural communities, accommodated and fed them and gave them training, especially in community leadership, sports coaching and refereeing.

## Commitment

This proved that the Commission and our programmes are adaptable and I must thank Government and the country's Divisional Officers for their support and input in ensuring that we continued to deliver on our commitment to develop our youth.

The Commission also continued to host international sporting events and to support sports teams travelling overseas for competions and for the prepatory build-up to the 2016 Olympic Games in Rio de Janeiro, Brazil.

The Commission's commitment to the development and funding of sports at all levels, especially our National Teams, truly showed what can be achieved when our Olympic Rugby Sevens men came home from Rio with Gold. Their triumph and the ensuing celebrations lifted the hearts of all Fijians, following a most difficult period, not only for sports, but also for the nation.





# Sports Development Programmes

## January - July 2016

The plans for Sports Development Programmes in the first seven months of 2016 were interrupted by Category 5 Tropical Cyclone Winston. In the wake of the devastation that the cyclone brought to the nation, the first order of the day was to support and serve those most severely affected.

The Fiji National Sports Commission responded to Government's call for all Government departments to deploy staff across the country for cyclone rehabilitation works at the main centres. The Sports Development staff responded, and spent a total of 60 days in rehabilitation works, assisting where they were most needed.

An account of the works carried out by Fiji Sports Commission employees is follows:

- · School clean ups;
- · Conducting initial damage assessments;
- Administration support at the Operations Centre, including recording and collating reports from officers engaged in the field;
- Carting drinking water to those urgently in need of potable water;

- Operating diesel generators to draw water from bore holes for people's immediate needs;
- Distributing and erecting tents for those whose homes were completely destroyed;
- Distributing tarpaulins, construction tools and clothing to the most needy;
- · Conducting census for ration distribution; and
- Distributing of food rations to every household in settlements and villages in the Lautoka and Nadi areas, as well as to islands in the Yasawa and Mamanuca Groups.

A review of our planned operations for this period saw the need to change our approach following Cyclone Winston. To avoid additional stress on affected communities, it was no longer appropriate to invite villages to host Outreach Programmes.

Instead, the Fiji Sports Commission paid for villagers and people from rural areas to stay with FSC and attend one of the three Train the Trainer Programmes that were conducted in Labasa, Lautoka and Sigatoka. One rural Sports Outreach Programme was also planned for this period.



## **Programme Reports**

## **Sports Outreach Programme**

One programme was conducted in Saqani, Cakaudrove, where 103 participants took part in seven sports: rugby union, rugby league, volleyball, soccer, tennis, netball and boxing. Twenty villages from four Tikinas in Cakaudrove District were involved in the programme, during which the Fitness Leader Concept was implemented for the first time.

## **Train the Trainer Programme**

Three programmes were conducted, one each in Labasa, Lautoka and Sigatoka. A total of 66 participants were accredited as coaches in volleyball, rugby union, and rugby league and as certified fitness leaders and sports administrators through the OSEP SIC Course.

## **Kids in Community Programme**

A total of 2208 students from 16 schools were engaged in the programme. The schools were from Naitasiri, Ovalau, and Labasa.

#### **Wellness Programmes**

A total of 2669 participants took part in the Wellness Programmes

that were conducted by the Commission, or in partnership with other stakeholders. The Colourful Explosion Walk for Health conducted in Lautoka attracted thousands of participants.

## **Community Assistance**

The Commission's Community Assistance initiatives benefited 685 participants through the following; fitness training and assessment for Fiji National Rugby League, Macuata Rugby Team Training Assistance and Schools Invitational Programme.

## **Staff Professional Development**

Josaia Tuinamata attended a Table Tennis Level 1 Accreditation Course, through an invitation by Fiji Table Tennis. Elesi Ikanidrodro attended a Just Play Accreditation Course, through the Fiji Football Association. Shavneel Prasad attended a Fiji Football Referee's Workshop, while Joji Liga and Josaia Tuinamata attended a Leadership Workshop for Master Educators from around the region, under the OSEP Programme. Joji Liga and Josaia Tuinamata conducted an internal continuous professional development workshop for the Sports Development staff, following the Leadership Workshop. All Sports Development staff attended the Tennis Hot Shots Programme, conducted by Tennis Australia.







# 2016 Sports Grants/Sporting Body Recepients

Each year, National Sports Organisations (NSOs) are given the opportunity to lodge an application with the Fiji National Sports Commission for sports grants, which fall into six categories, as follows:

Overseas Sports Tours: To send teams or individual athletes overseas for international competitions. This grant is available only for ranking or qualifying tournaments.

**Host International Tournaments:** This grant is for the hosting of international tournaments and local events with overseas participants.

**Short term Expert Grant:** For engaging overseas experts on a short-term basis, to assist local development officers.

**Sports Scholarship Grants:** To send elite athletes and technical officials overseas for high-level training, on a short-term basis.

**Special One-Off Grants:** Available to national teams attending or hosting major international events.

**International Coaches Grant:** For the appointment of overseas coaches for the development of national teams.

NSOs applying for grants must be certified by the Fiji National Sports Commission as meeting the necessary criteria.



In order to qualify as eligible, each NSO must show that it practices good sports governance, possesses development plans for the sport and its funding, and show accountability to its athletes, members and the sport.

## FIJI NATIONAL SPORTS COMMISSION

I have audited the accompanying financial statements of the Fiji National Sports Commission ("the Commission"), which comprises the statement of financial position for the seven months period ended 31 July 2016, and the statement of income and expenditure, statement of changes in equity and statement of cash flows for the year ended and a summary of significant accounting policies and other explanatory information as set out in notes 1 to 22.

## Directors and Management's Responsibility for the Financial Statements

The directors and management are responsible for the preparation and fair presentation of these financial statements in accordance with International Financial Reporting Standards for Small and Medium-sized Entities and the requirements of Fiji National Sports Commissions Decree 2013. #### 1. General Information

Fiji National Sports Commission ("the Commission") is a body corporate incorporated under Fiji National Sports Commission Decree No.5 of 2013 and domiciled in Fiji. The address of the Commission's registered office is 220 Laucala Bay Road, Suva, Fiji Islands. The Commission is primarily involved in the promotion and development of sports in Fiji.

The financial statements were authorised for issue with a resolution of the members of the Commission on 28% Nov 2017.

The significant accounting policies which have been adopted in the preparation of these financials statements are:

#### 2. BASIS OF PREPERATION

## (a) Statement of compliance

The financial statements of the Commission has been prepared in accordance with International Financial Reporting Standards for Small and Medium-sized Entities ('IFRS for SMEs').

## (b) Basis of measurement

The financial statements have been prepared on the historical cost basis and do not take into account of changing money values or except, where stated, current valuations of non-current assets.

## (c) Functional and presentation currency

These financial statements are presented in Fijian currency, which is the Commission's functional currency. All financial information presented in Fijian currency has been rounded to the nearest dollar.

## (d) Use of estimates and judgments

The preparation of the financial statements in conformity with IFRS for SMEs, management of the Commission is required to make judgments, estimates and assumptions that affect the application policies and the reported amounts of assets, liabilities, income and expense. Actual results may differ from these estimates. Estimates and underlying assumptions are reviewed on an on-going basis.

Revisions to accounting estimates are recognized in the period in which estimates are revised and in any future periods affected.

Judgments made by management in the application of IFRS for SMEs that have significant effects on the financial statements and estimates with a significant risk of material adjustments in the next year are disclosed, where applicable, in the relevant notes to the financial statements.

Accounting policies are selected and applied in a manner which ensures that the resulting financial information satisfies the concepts of relevance and reliability, thereby ensuring that the substance of the underlying transactions or other events is reported.

## 3. SIGNIFICANT ACCOUNTING POLICIES

The accounting policies set out below have been applied consistently to all periods presented in these financial statements, and have been applied consistently by the Commission.

## (a) Cash and cash equivalents

Cash and cash equivalents are carried in the balance sheet at cost. For the purpose cash flow statement, cash and cash equivalents comprise cash on hand and cash at bank.

## (b) Foreign currency

Foreign currency transactions are translated to Fijian currency at rates of exchanging ruling at the dates of the transactions. Amounts receivable and payable in foreign currencies are converted to Fijian currency at the rates of exchange ruling at balance date. All exchange gains or losses whether unrealized are included in the income statement.

## 3. SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

## (c) Deferred income

Government grant in aid and assets acquired at no cost to the Commission are capitalised and systematically recognised as other income on the basis of the expected lives of the assets to which the grant relates.

Grants received before the revenue recognition criteria are satisfied are recognised as a liability.

## (d) Government grant

The Commission receives operating grant from the Government. Operating grants that compensate the Commission for expenses incurred are recognised as revenue in the income statement on a systematic basis in the same period in which the expenses are incurred. Operating grants that are used to compensate the cost of an asset are recognised in the income statement as revenue on a systematic basis over the useful life of the assets.

The Commission also receives sporting grant from the Government. The sporting grants are disbursed by the Commission to various sporting organisation and agency for overseas tours, sports scholarships, and engagement of short term experts and hosting of international tournaments.

Furthermore, the Commission receives international coaches grant from the Government which is utilised to pay the salary and other benefits for the full time international engaged by various sporting organisation.

#### (e) Income tax

Income of the Commission is exempt from income tax in accordance with Section 17(24) of the Income Tax Act.

#### (f) Property, plant and equipment

Property, plant and equipment are stated at cost less accumulated depreciation and impairment loss. Cost includes expenditure that is directly attributable to the acquisition and installation of the items.

Property, plant and equipment are depreciated on a straight-line basis over their estimated useful lives using the following rates:

Computer Equipment 20% Furniture and Fittings 20% Motor Vehicles 20%

Profits and losses on disposal of property, plant and equipment are taken into account in determining the results for the period.

## (g) Employee entitlement

#### Annual leave

The liability for annual leave is recognized in the provision for employee entitlement. Liabilities for annual leave are expected to be settled within 12 months of the reporting date and are measured at their nominal values using the current remuneration rate which is expected to be applied at the time of settlement.

## Long service leave

The Commission does not have any long service leave policy in place. All employee entitlement is expected to be used by employees within the fiscal year.

## Wages and salaries

Liabilities for wages and salaries expected to be settled within 12 months of the reporting date are accrued up to the reporting date.

#### Defined contribution plans

 $Contributions \ to \ Fiji\ National\ Provident\ Fund\ (FNPF)\ by\ the\ Commission\ are\ expensed\ when\ incurred.$ 

## (h) Trade and other payables

Liabilities are recognized for amounts to be paid in the future for goods and services rendered. Creditors and accruals are stated at cost.

#### 3. SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

#### (i) Leased assets

The determination of whether an arrangement is, or contains a lease is based on the substance of the arrangement at inception date of whether the fulfillment of the arrangement is dependent on the use of a specific asset or assets or the arrangement conveys a right to use the asset.

Finance leases, which transfer to the Commission substantially all the risks and benefits incidental to ownership of the leased item, are capitalized at the inception of the lease at the fair value of the leased property or, if lower, at the present value of the minimum lease payments. Lease payments are apportioned between the finance charges and reduction of the lease liability so as to achieve a constant rate of interest on the remaining balance of the liability. Finance charges are reflected in income statement.

Subsequent to initial recognition, the asset is accounted for in accordance to the accounting policy applicable to that asset.

## (j) Comparative

Where necessary, amounts relating to prior years have been re-classified to facilitate comparison and achieve consistency in disclosure with current financial year amounts.

## (k) Value Added Tax (VAT)

All the revenue, expenses, assets and liabilities are recorded at VAT inclusive prices. This treatment is based on the advised provided by Fiji Revenue Customs Authority on 31 January 2014. The reasons are as follows:

The Commission is basically providing funding and development of sports in Fiji and this is done through government grant funding. With such set up and with no taxable/business activities, the Commission is not registered for VAT. Any expenses incurred for which the Commission is charged VAT, the VAT portion will be cost to the Commission.

The independent risk control process does not include business risks such as changes in the environment, technology and industry. They are monitored through the Commission's strategic planning process.

## (a) Market risk

Market risk does not apply to the Commission since it is not involved in trading activities.
