## PARLIAMENTARY - WRITTEN QUESTION NO. 136/2019 - Fri. 17<sup>th</sup> May, 2019

## **QUESTION:**

Hon Ratu Naiqama Lalabalavu to ask the Prime Minister and Minister for iTaukei Affairs and Sugar Industry – Can the prime Minister explain to Parliament the number of native leases which have been issued by the TLTB since 2010?

## **RESPONSE:**

1. Mr. Speaker, the iTaukei Land Trust Board (TLTB) was established in 1940 and mandated by law under the iTaukei Land Trust Act 1940 to control and administer iTaukei land for the benefit of landowners.

- 2. The TLTB continues this role today with a view to support livelihoods of many Fijian citizens and investors interested in making a living through the development of iTaukei land.
- 3. Between 2010 to the end of 2018, TLTB issued 18,787 leases on iTaukei land for various uses such as agriculture, residential, commercial, industrial, government, tourism, water catchment and, more recently, forest conservation leases. (Refer to details in Tables 1 & 2).
- 4. The TLTB lease portfolio has increased in count by 23% from 35,725 in 2010 to 43,943 at the end of 2018. The total leased area at the end of 2018 was 421,301.9 hectares.

5. The Annual Rent of the Board's lease portfolio significantly increased by 48% from 2010 to 2018. This is an annual growth rate of 4% per year for new leases issued. (Refer to Table 1 below.)

- 6. A total of 10,052 new leases for residential purpose were issued from 2010 to 2018. The trend of new leases issued by TLTB from 2010 to 2018 demonstrates the demand in land for residential purposes. This is due to the increasing demand for housing in Fiji considering the 2017 population and housing census results, coupled with initiatives by Government to encourage Home Ownership such as the First Home Owners Grant.
- 7. In 2010, forestry leases occupied the most area of leased iTaukei land and agricultural leases accounted for the highest Annual Rental. (Refer to Table 3).
- 8. By 2018, residential leases increased by 46% in count, and its leased area increased by 28% and currently demands the highest lease rental. (Refer to Table 4).
