### **Oral Questions**

- 183/2019 Hon. Joseph Nand to ask the Minister for Industry, Trade, Tourism, Local Government, Housing and Community Development – Can the Minister update Parliament on the Revitalising Informal Settlements and their Environment (RISE) Programme.
