It was a historical moment for the Speaker, His Excellency Sir Ratu Epeli Nailatikau and the

Members of Parliament to have the United Nations Secretary-General (UNSG) His Excellency Antonio Guterres address them during Parliament sitting on Thursday, May 16th, 2019. H.E. Guterres said that being in the Parliament of Fiji, he felt twice at home. At home because he was in Fiji and at home because he was in Parliament.

The UNSG had spent 26 years in Parliament, with six and a half years being the Prime Minister of Portugal.

He acknowledged that Parliament demonstrated another of Fiji's important achievements.

"Representatives from different political parties, backgrounds and experiences are here together to debate and decide on national issues.

"This was not always the case in many parts of the world, and I congratulate you on efforts to make this parliament – and Fiji itself – a place of inclusiveness, equality, diversity and tolerance.

"We need that spirit more than ever at this troubled time," H.E. Guterres said.

The UNSG also congratulated the Fijian Parliament for being the first Parliament in the world to undertake a Sustainable Development Goals self-assessment.

"Your Parliament Speaker's Debates on the Goals have prompted national discussions between political leaders and civil society, the private sector and academia on Fiji's development policies.

"I applaud your commitment to sustainable development to improve the lives of all Fijians," the UNSG added.

Members of Parliament had an opportunity to meet with the UNSG after his address.

I am a servant of this House and the challenges that comes with this responsibility, I will not take lightly but to the best of my ability, continue to ensure that this office delivers with diligence, dianity and honour.

These were the words of the newly-appointed Speaker of the Fijian Parliament, His Excellency Sir Ratu Epeli Nailatikau, while delivering his acceptance speech in the House.

H.E. Sir Ratu Epeli Nailatikau, who was nominated by Government, succeeded the late Hon. Dr Jiko Luveni who passed away last December.

The former President was appointed following a secret ballot voting process in the House, winning 30 votes against 21 to Opposition nominee and Suva Lawyer, Tanya Waqanika.

"The Speaker does not represent a political party or a certain segment of the electorate but it is important to point out that he or she is appointed by the Newly-appointed Speaker of the Fijian Parliament, His Excellency Sir Ratu Epeli Nailatikau in his office.

the Fijian people who are represented through you, their representatives, in this House," Sir Ratu Epeli said.

"Just as you feel politically-responsible to serve the Fijian people, as Speaker, my role and responsibility is to equip you to perform your principle role as legislators and decision makers.

"My commitment to this House is to be completely impartial between Members of one political party and another. That is what it is about. I will do my best faithfully and honourably and effectively serve this House in the period ahead."

H.E. Sir Ratu Epeli also paid homage to his predecessor, the late Hon. Dr Luveni for her exemplary services to the nation.

"In this election, I follow in the path of many distinguished Speakers none more so than the late Hon. Dr Luveni, our first woman Speaker who has now set the standard for all those who will follow. She was said to have combined ability, firmness and impartiality with dignity and good temper. I shall endeavor to be a worthy successor in that tradition."

The Speaker also urged Members of Parliament to serve the nation well.

"As political leaders, we must dedicate ourselves to serve the national interest and advance the common good.

"In this regard Honourable Members, I encourage this House to embrace collegiality, fellowship, mutual and reciprocal respect when conducting all its proceedings. Let us be the agents that promote the unity and advancement of this indivisible Nation."

Meanwhile, the Speaker thanked the Government and his family for their unwavering support towards his new role.

PARLIAMENT PRESS GALLERY LAUNCHED

Media personnel wanting to cover Parliament proceedings during sitting days now have the luxury of using the press gallery inside the Chamber following its official launch in April. While launching the gallery, the Speaker His Excellency Sir Ratu Epeli Nailatikau said the initiative acknowledged the unique and important relationship between Parliament and the media.

The Government of China funded the project which was one of the wishes of the late Speaker, Dr Jiko Luveni.

"The launching of the media gallery today is not an isolated development but part of Parliament's broader initiative under its 2018-2022 Strategic Plan to increase citizen awareness and engagement of Parliament and its parliamentary processes," Hon. Ratu Epeli said.

"In 2017, after a lapse of several years, Parliament continued with the recording and broadcasting of parliamentary proceedings keeping up with the global trend of opening up Parliament sessions to the media, which is the norm, particularly in most Commonwealth countries. There is also work in progress to record and broadcast committee meetings to the media as this is where much of the parliamentary work is done.

Hon. Ratu Epeli hoped that the launch of the media gallery would signify a new journey and mutual understanding between Parliament and the media and that it would substantially contribute to the cause of good governance for the benefit of the people of Fiji.

China's Ambassador to Fiji, His Excellency Mr Qian Bo said they were pleased to extend their assistance to the Parliament of Fiji, adding it was part of their continued support to Fiji.

Acting Secretary-General to Parliament Mrs Viniana Namosimalua said the initiative was part of their journey of reaching out to members of the public, civil society groups and the wider community through the media.

Meanwhile, Fijian Media Association General-Secretary Stanley Simpson thanked Parliament, saying that this would allow journalists to do their work much more effectively for the benefit of the people of Fiji.

GUIDE TO MAINSTREAMING SDGs WITHIN PARLIAMENT COMMITTEE PROCESSES LAUNCHED

Building on previous efforts of strengthening the oversight, scrutiny of In 2017, the Fijian Parliament made history by being the first in the world laws and representation role of the legislature, the Parliament of the Republic of Fiji with its partners, launched a toolkit that will see the integration of the Sustainable Development Goals (SDGs) across all of its parliamentary Committee work.

Every progress towards achieving the aspirations of the SDGs contributes directly to improving the lives of citizens. The day to day concerns of Fijians, such as jobs, education, healthcare and access to justice, amongst others, are all related to the SDGs.

The aim of the Guidance Note is to assist Committees in making the SDGs central to the work of the Parliament and in engaging effectively with the SDGs in all areas of Committee work.

It was developed with the assistance of the United Nations Development Programme (UNDP) Pacific Office in Fiji through its Fiji Parliament Support Project (Phase II) which is jointly funded by the Governments of Japan, Australia and New Zealand.

Titled, 'Oversight of the Implementation of the SDG: Guidance Note for the Standing Committees of the Parliament of the Republic of Fiji', the toolkit contains tangible and concrete actions that Committees can use to improve their oversight role.

In his address at the launch of the Guidance Note, the Speaker for the Parliament of the Republic of Fiji, His Excellency Sir Ratu Epeli Nailatikau, acknowledged the partnership that was leveraged to produce the toolkit and reaffirmed the commitment of the Fiji Parliament in improving the lives of people through effective scrutiny.

"The SDGs are a robust framework around which Parliament can base its strategic plans and pursue its own oversight and accountability work and we look forward to the continuation of a strong partnership between the Parliament of Fiji, UNDP and other development partners", said Sir Ratu Epeli.

"The SDGs are an opportunity for parliamentarians to demonstrate their commitment to improving people's lives and the health of the planet.

"A key priority for government is the localization of the SDGs, which includes clear targets and baselines. He added, "Therefore SDGs monitoring, and oversight should be mainstreamed into the parliament's legislative process and oversight functions - the achievement of the SDGs requires engaged and committed parliaments in order to enable governments to act, while holding them accountable to their commitments."

to carry out a self-assessment exercise on the SDGs.

"The guidance note is a direct follow up to the findings and proposed action plan of the parliamentary SDG self-assessment that recommended producing a toolkit for the committees to undertake monitoring and assessment of the SDGs related to their respective subject areas", said Sir Ratu Epeli.

He added, "it is a living document that will be periodically updated and refined with feedback, lessons-learned and case studies from on-going efforts related to parliamentary committee oversight of SDG attainment progress."

The SDGs were adopted, as an integral part of 'Transforming our world: the 2030 Agenda for Sustainable Development', by all 193 Member States of the UN on 25 September 2015.

Also referred to as the Global Goals, the ambitious plan to end poverty, protect the planet and ensure that all people enjoy peace and prosperity, came into force on 1 January 2016 and has 2030 as the target date for achievement.

In echoing the significance of the launch, the Resident Representative of the UNDP Pacific Office in Fiji, Vineet Bhatia, congratulated the Fijian Parliament for the completion of the Guidance note and its commitment to participate directly in Fiji's development process.

"It is widely acknowledged that good governance processes need to be inclusive and participatory. To engage meaningfully, citizens need to know about Agenda 2030, and local actors (including Parliament, civil society, private sector, and communities as a whole) have to be engaged in a meaningful way and play their role in implementation", said Bhatia.

"Parliament's mandate offers you as MPs an opportunity to increase your engagement in national development and monitoring progress towards the SDGs, therefore ensuring better development outcomes for your citizens."

He added, "Standing Committee members are uniquely positioned in parliament to champion the SDGs and provide effective oversight of its progress. This Guidance Note provides Committees with the necessary direction to integrate the SDGs into their everyday work: by mainstreaming the SDGs monitoring and oversight into the Committees' legislative and oversight functions."

The Guidance Note has been developed for the Parliamentary Committees as a toolkit to promote and improve Committee engagement in the achievement of the SDGs.
