
The Council's strategic priorities are: -

ORGANISATION REVIEW

The Council's performance is directly related to the capacity of the staff and the number of people that are in office to execute the programme. Major changes are called for in Levuka to sharpen accountability amongst which is the need to go into accrual accounting sometime into the future. Unfortunately the Council does not have professionally qualified accounting staff to carry forward the momentum training would be required in the long term.

The key areas of need are in accounting and finance, townscape management, heritage management and town planning. These have not been looked into in any great detail because of lack of resources. If there is any area of government support that may be needed it is human resource department. It is a major challenge for Levuka and needs to be seen in its proper perspective.

INDEPENDENT AUDITOR'S REPORT

To the members of Levuka Town Council

I have audited the accompanying financial statements of Levuka Town Council, which comprises the statement of financial position as at 31 December 2011, and the statements of revenue and expenditure, and a summary of significant accounting policies and other explanatory information as set out on Notes 1 to 7.

Management's Responsibility for the Financial Statements

The Special Administrator and management are responsible for the preparation and fair presentation of these financial statements in accordance with International Financial Reporting Standard for Small and Medium-sized Entities and the requirements of the Local Government Act. This responsibility includes: designing, implementing and maintaining internal controls relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error, selecting and applying appropriate accounting policies; and making estimates that are reasonable in the circumstances.

Auditor's Responsibility

My responsibility is to express an opinion on these financial statements based on the audit. I have conducted the audit in accordance with International Standards on Auditing. Because of the matter described in the Basis for Disclaimer of Opinion paragraph, however, I was not able to obtain sufficient appropriate evidence to provide a basis for an audit opinion.

Basis for Disclaimer of Opinion

According to Section 57 of the Local Government Act, Levuka Town Council is required to prepare and present its annual financial statements in accordance with accounting standards approved by the Fiji Institute of Accountants. The Council is yet to comply with the International Financial Reporting Standards for Small and Medium-sized Entities ("IFRS for SMEs"). Accordingly, I am not able to determine effects of adjustments, if any, which may be necessary if the financial statements were prepared under IFRS for SMEs.

Disclaimer of Opinion

Because of the significance of the matter described in the Basis for Disclaimer of Opinion paragraph, I am unable to and do not express an opinion as to whether the financial statements present fairly in accordance with International Financial Reporting Standards for Small and Medium-sized Entities the financial position of Levuka Town Council as at 31 December 2011 and the results of its operations for the year then ended.

Other Matter

There was general lack of internal controls on financial reporting and activities of the Council in 2011 which I have highlighted to both the Council and the Ministry of Local Government in an Audit Memorandum.
