

## PARLIAMENT OF THE REPUBLIC OF FIJI

# **MINUTES**

of Proceedings of Parliament at Suva on Friday, Twenty-fifth Day of March, 2022

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.

#### 3. <u>MEMBERS PRESENT</u>

All Members were present except for the Hon. Adi Litia Qionibaravi, Hon. Peceli Vosanibola and Hon. Pio Tikoduadua.

#### 4. <u>CONFIRMATION OF MINUTES</u>

The Leader of the Government in Parliament the Hon. Inia Seruiratu, moved that the Minutes of the sitting of Parliament held on Thursday, 24 March 2022 as previously circulated, be taken as read and be confirmed.

#### 5. <u>COMMUNICATIONS FROM THE CHAIR</u>
