MINUTES

of Proceedings of Parliament at Suva on Thursday, Twelfth day of May, 2022

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.
- 3. <u>MEMBERS PRESENT</u>

All Honourable Members were present except for the Hon. Adi Litia Qionibaravi.

The Hon. Rosy Akbar joined the Parliament sitting virtually.

4. ADMINISTRATION OF OATH OR AFFIRMATION

Mere Tuisalalo Naulumatua took the Oath of Office for Members of Parliament and the Oath of Allegiance, and subsequently delivered her maiden speech.

11. MOTION IN THE NAME OF THE HON. PROF. BIMAN PRASAD

Hon. Prof. Biman Prasad moved that Parliament authorises the Standing Committee on Economic Affairs to assess the impact of direct initiatives to farmers in the agricultural sector in particular the distribution of seeds and seedlings for cash crop, help in the form of materials provided to dairy farmers, provision of irrigation pumps/piping, rice planting, ploughing and harrowing of land by the Ministry of Agriculture, handling of breeder goats/sheep and report back at the next sitting of Parliament.

13. <u>QUESTIONS</u>

- 121/2022 Hon. Pio Tikoduadua asked the Minister for Education, Heritage and Arts, and Local Government – Can the Minister inform Parliament who is paying the Suva City Council for its garbage collection services within the Nasinu municipal boundary.
- 122/2022 Hon. Virendra Lal to ask the Minister for Women, Children and Poverty Alleviation – Can the Minister update Parliament on the Child Protection Programme, which has an allocation of \$50,000 in the Revised 2021-2022 Budget.
- 123/2022 Hon. Simione Rasova asked the Minister for Agriculture, Waterways and Environment Can the Minister update Parliament on the construction of seawalls in coastal villages in Kadavu.
- 124/2022 Hon. Veena Bhatnagar asked the Minister for Commerce, Trade, Tourism and Transport – Following the enactment of the Investment Act 2021 and the Investment Fiji Act 2022, can the Minister inform Parliament on the actions taken by the Ministry to create awareness on the new processes.
- 125/2022 Hon. Peceli Vosanibola asked the Minister for Fisheries Can the Minister update Parliament on the initiatives in place to ensure the supply of fish to PAFCO.
- 126/2022 Hon. George Vegnathan asked the Minister for Agriculture, Waterways and Environment – Can the Minister inform Parliament on the impact of commercial Kava export to Australia which was approved by the Australian Government in December 2021.
- 127/2022 Hon. Tanya Waqanika asked the Minister for Health and Medical Services – Can the Minister update Parliament on the facilities available to women for PAP Smear Screening.
- 128/2022 Hon. Selai Adimaitoga asked the Attorney-General and Minister for Economy, Civil Service, Communications, Housing and Community Development – Can the Minister inform Parliament on why Fiji's debt

remains sustainable and cannot be compared to the Sri Lankan crisis.

The responses to the Oral and Supplementary Questions were provided by the respective Ministers. The Hon. Speaker advised Honourable Members that Oral Question 122/2022 would be deferred to Friday, 13 May 2022, in addition to the questions listed down for Friday's Order Paper.
