- Hon. Jese Saukuru to ask the Minister for Infrastructure, Meteorological Services, Lands and Mineral Resources – Can the Minister update Parliament on the designation of iTaukei land to the Land Use Unit since 2018, in particular –
  - (a) the total area of land designated under the Land Use Act 2010 to the Land Use Unit from the iTaukei landowners; and

A total area of 10,080.42 hectares has been designated under the Land Use Act 2010 from the I Taukei landowners.

(b) What percentage of such land has been leased and what returns have been paid out to iTaukei land owning units.

27.88 percent of land which is a total area of 2,099.13 hectares has been leased out under the Land Use Act 2010. Moreover, this generated \$ 11,435,001.57 lease money that is being paid out to land owing Units.
