**191/2023 Hon. Naisa Tuinaceva to ask the Attorney-General and Minister for Justice – Can the minister update parliament on the total compensation that has been paid out by the accident compensation commission fiji from the period of January to September 2023**

**RESPONSE BY THE ATTORNEY-GENERAL AND MINISTER FOR JUSTICE**

**CAN THE MINISTER UPDATE PARLIAMENT ON THE TOTAL COMPENSATION THAT HAS BEEN PAID OUT BY THE ACCIDENT COMPENSATION COMMISSION FIJI FROM THE PERIOD OF JANUARY TO SEPTEMBER 2023–**

**A. Supreme Court**

The Accident Compensation Commission Fiji is mandated pursuant to section 18 of the Accident Compensation Act 2017 to pay compensation to all people in Fiji who suffer injuries or death, resulting from accidents. The Act further states that the compensation must be paid in lump sums.

For death, the total amount of compensation that was paid amounted to \$3450 000.00. These compensation was paid to 46 Applicants.


In terms for compensation paid for injuries, the total amount that was \$6949 500.00. This compensation was paid to 336 applicants.

The total compensation paid by the Commission for the period of January-September, 2023 is \$10399 500.00. This was paid to 382 applicants.

The particulars and details of the monthly payments are also available and we would be delighted to share the same with the Hon. Tuinaceva should he request for it.
