MINUTES

of Proceedings of Parliament at Suva on Monday, Fifteenth day of April, 2024

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.

3. MEMBERS PRESENT

All Honourable Members were present.

4. CONFIRMATION OF MINUTES

The Leader of the Government in Parliament the Hon. Ro Filipe Tuisawau moved that the Minutes of the sitting of Parliament held on Friday, 15 March 2024 as previously circulated, be taken as read and be confirmed.

Hon. Speaker welcomed all Honourable Members to the sitting, those seated in the gallery and those watching the live proceedings on television and the internet. He also welcomed the PL100 law students from the University of the South Pacific.

Hon. Speaker informed all Honourable Members that the back-to-office report for the 28th Session of the Conference of the Parties (COP28), which was held in Dubai, United Arab Emirates was available in the Library for reference. He also informed that the newly elected Chairperson of the Standing Committee on Natural Resources was the Hon. Tomasi Tunabuna and the newly elected Deputy Chairperson was the Hon. Jone Usamate.

Hon. Speaker also informed Honourable Members on the deliberation of the Business Committee meeting on Thursday, 11 April 2024 on the existing workload of the Standing Committees and the Chairmanship and Deputy for the Standing Committees. He further informed Honourable Members that the Hon. Prime Minister had agreed to the review the Chairmanship and Deputy and any changes would be communicated accordingly.

- 6/2024 Hon. Sakiusa Tubuna asked the Deputy Prime Minister and Minister for Education, Tourism and Civil Aviation Can the Deputy Prime Minister update Parliament on the forthcoming South Pacific Tourism Exchange (SPTE) 2024 event to be hosted by Fiji.
- 7/2024 Hon. Viam Pillay asked the Minister for Multi-Ethnic Affairs and Sugar Industry Can the Minister inform Parliament how the Ministry is assisting farmers and cane harvesting co-operatives to prepare their harvesters and personnel for the crushing season.
- 8/2024 Hon. Sashi Kiran asked the Deputy Prime Minister and Minister for Education, Tourism and Civil Aviation Can the Deputy Prime Minister update Parliament on the strategic measures that the

Ministry is taking to address the issue of outdated education curriculum.
