

PARLIAMENT OF THE REPUBLIC OF FIJI

MINUTES

of Proceedings of Parliament at Suva on Monday, Twenty-ninth day of September, 2025

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.

3. <u>ATTENDANCE</u>

(a) The following Honourable Members obtained approval from the Hon. Speaker for absence from Parliament –

4. CONFIRMATION OF MINUTES

The Leader of the Government in Parliament the Hon. Ro Filipe Tuisawau moved that the Minutes of the sitting of Parliament held on Friday, 8 August 2025 as previously circulated, be taken as read and be confirmed.

Motion agreed to unanimously.

5. COMMUNICATIONS FROM THE CHAIR

The Hon. Speaker welcomed all Honourable Members to the September–October sitting period as well as those seated in the gallery, and those following the proceedings through television and online platforms.

1. Establishment of PIPA

The Hon. Speaker informed that the conclusion of the 5th Pacific Islands Parliaments Conference, held in Natadola on 28 August 2025, signified not the closure of the PIPG chapter but the establishment of the Pacific Inter-Parliamentary Assembly (PIPA), an institution intended to strengthen regional integration and amplify the collective voice of Pacific parliaments globally.

2. 2025 Fiji Youth Parliament

The Hon. Speaker informed Honourable Members that Parliament had successfully hosted the 2025 Fiji Youth Parliament from 8 to 12 September 2025, as part of Parliament's effort to nurture future leaders. He thanked Members who contributed to the training and mentorship of the Youth Parliamentarians and those that provided support during their debates. He also advised of the possibility of another Youth and Women's Mock Parliaments in the coming year as part of the continuous empowerment initiatives and process in national politics.

3. Request for Extension – Standing Committee on Economic Affairs

The Hon. Speaker also advised the Honourable Members of the request from the Chairperson of the Standing Committee on Economic Affairs, which was agreed to by the Business Committee, for an extension of reporting back time on the following Bills –

- (a) Credit Union Bill 2025; and
- (b) Employment Relations (Amendment) Bill 2025.

The request was unopposed by all Honourable Members.

4. Referral of Annual Reports

The Hon. Speaker informed Honourable Members of the re-assignment of some annual reports.

5. Back-to-Office Report

The Hon. Speaker thanked Hon. Premila Kumar for her timely report on the Tongan Women's Practice Parliament Workshop which was held in Nuku'alofa, Tonga, and that the report was available in the Library.

6. Hon. Sanjay Kirpal's Status

The Hon. Speaker informed Honourable Members that the Hon. Sanjay Kirpal has confirmed his intention of remaining an Opposition Independent Member for the remainder of the parliamentary term. The Hon. Speaker further informed that he would now recognise the Leader of the Opposition's group as the Group of 13 Bloc.

8. QUESTIONS

Oral Questions

- Hon. Alvick Maharaj asked the Deputy Prime Minister and Minister for Finance and Strategic Planning, National Development and Statistics Given the ADB's April 2025 forecast of 3.0% GDP growth and inflation of 2.9% in May 2025, what new, targeted fiscal measures beyond the general budget will the government implement in Q3 and Q4 to ease the cost of essential goods for low-income households, and how will their impact be assessed over the next six months.
- Hon. Jovesa Vocea asked the Prime Minister and Minister for Foreign Affairs, Civil Service and Public Enterprises Can the Prime Minister update Parliament on the recent signing of the Memorandum of Understanding (MOU) between Fiji and Vanuatu on development co-operation.
- Hon. Parveen Bala asked the Minister for Housing and Local Government Can the Minister update Parliament on the progress of the relocation of squatter tenants from Nabua Muslim League settlement.

- Hon. Lenora Qereqeretabua asked the Minister for Employment, Productivity and Workplace Relations Can the Minister update Parliament on the impacts and advantages of transferring the compensation processing from the ACCF to the Ministry.
- Hon. Virendra Lal asked the Minister for Health and Medical Services

 Can the Minister inform Parliament on the retention incentives the Ministry has in place for the following specific categories of health professionals, excluding nurses: medical officers, dental officers, medical laboratory scientists, medical imaging technologists/radiologists and pharmacists.
- Hon. Taito Rokomatu asked the Deputy Prime Minister and Minister for Finance and Strategic Planning, National Development and Statistics Can the Deputy Prime Minister update Parliament on the FRCS compliance strategy on the revenue collection in the last financial year.
- Hon. Hem Chand asked the Minister for Education Can the Minister inform Parliament on the specific subjects where there is shortage of teachers in secondary schools.
- Hon. Aliki Bia asked the Minister for Housing and Local Government

 Can the Minister inform Parliament of the recent launching of the three key initiatives by Housing Authority, their objectives, target beneficiaries, and its impact on housing accessibility and affordability across Fiji.
- Hon. Viam Pillay to ask the Minister for Multi-Ethnic Affairs and Sugar Industry Can the Minister update the Parliament on FSC's plans to bring foreign workers to harvest sugar cane on areas affected by labour shortages.
- Hon. Esrom Immanuel asked the Minister for Education Can the Minister update Parliament on the Waste to Climate Action: Scaling Sustainable Composting in Fijian Schools initiative.

Written Question

- Hon. Inosi Kuridrani asked the Minister for iTaukei Affairs and Culture, Heritage and Arts Can the Minister inform Parliament of the expected beneficiaries of the iTaukei Resource Owners Support and Development Fund for the 2025–2026 financial year with respect to the following
 - (a) the estimated number of land-owning groups (such as *mataqali* or *yavusa*) set to benefit, along with their provincial distribution;
 - (b) the criteria and scoring system that will guide eligibility and selection; and
 - (c) any pilot projects or case studies conducted or underway, including key successes and challenges encountered.

The responses to the Oral and Supplementary Questions were provided by the respective Ministers. Oral question 139/2025 was omitted pursuant to Standing Order 43(3), as the Hon.
