

### PARLIAMENT OF THE REPUBLIC OF FIJI

## **MINUTES**

of Proceedings of Parliament at Suva on Friday, Eighteenth day of July, 2025

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Lord's Prayer.

# 7. MOTION IN THE NAME OF THE HON. PRIME MINISTER AND MINISTER FOR FOREIGN AFFAIRS, CIVIL SERVICE AND PUBLIC ENTERPRISES, AND INFORMATION

The Prime Minister and Minister for Foreign Affairs, Civil Service and Public Enterprises, and Information the Hon. Sitiveni Rabuka moved pursuant to Standing Order 129, that a Special Committee on Sugar Industry be established to undertake a comprehensive review of the Sugar Industry in Fiji and to provide strategic recommendations for its transformation and long-term sustainability. - (c) Hon. Viliame Gavoka, Deputy Prime Minister and Minister for Tourism and Civil Aviation;
- (d) Hon. Manoa Kamikamica, Deputy Prime Minister and Minister for Trade, Cooperatives, Micro, Small and Medium Enterprises and Communications;
- (e) Hon. Charan Singh, Minister for Multi-Ethnic Affairs and Sugar Industry;
- (f) Hon. Inia Seruiratu, Leader of the Opposition (or his nominee);
- (g) a Member designated by the Leader of the Opposition; and
- (h) Hon. Ioane Naivalurua, Minister for Policing, and Leader of the Group of 11 Bloc (or his nominee).

Motion seconded.
