

PARLIAMENT OF THE REPUBLIC OF FIJI

MINUTES

of Proceedings of Parliament at Suva on Friday, Second day of May, 2025

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.

The Hon. Speaker welcomed all Honourable Members to the sitting of Parliament, those seated in the gallery and those watching the live proceedings on television and the internet. Hon. Speaker also welcomed the final group of PL 100 School of Law and Politics Students from the University of the South Pacific.

The Hon. Speaker informed all Honourable Members that the uncorrected *Hansard* report for yesterday's sitting would be circulated once finalised.

7. QUESTIONS

Oral Questions

- 60/2025 Hon. Jone Usamate asked the Minister for Public Works, Meteorological Services and Transport Can the Minister inform Parliament what criteria determines whether FRA or PWD handles specific infrastructure projects.
- Hon. Taito Rokomatu asked the Deputy Prime Minister and Minister for Tourism and Civil Aviation Can the Deputy Prime Minister update Parliament on the Government's strategy to maximise economic benefits from Fiji's growing cruise tourism sector.
- Hon. Semi Koroilavesau asked the Deputy Prime Minister and Minister for Tourism and Civil Aviation Can the Deputy Prime Minister inform Parliament on the Ministry's plans to address the recent decline in tourism arrivals and improve industry performance.

- Hon. Esrom Immanuel asked the Deputy Prime Minister and Minister for Trade, Co-operatives, Micro, Small and Medium Enterprises and Communications Can the Deputy Prime Minister update Parliament on the Cybersecurity partnership with Australia, following the signing of the Cybersecurity Cooperation Memorandum of Understanding last year.
- 64/2025 Hon. Faiyaz Koya asked the Deputy Prime Minister and Minister for Trade, Co-operatives, Micro, Small and Medium Enterprises and Communications Can the Deputy Prime Minister inform Parliament on what indications have been made or given with respect to the new trade platform of Indo-Pacific Economic Framework and its implications on Fiji.
- Hon. Lynda Tabuya to ask the Deputy Prime Minister and Minister for Tourism and Civil Aviation Can the Deputy Prime Minister update Parliament on major tourism related investment projects for road and jetty upgrades in Vanua Levu under the *Na Vualiku* Programme.
- Hon. Parveen Bala to ask the Minister for Lands and Mineral Resources Can the Minister inform Parliament when will the residents of Cuvu receive the 99 year lease which was announced on 12 March 2024 by the Government.
- Hon. Jovesa Vocea asked the Deputy Prime Minister and Minister for Trade, Co-operatives, Micro, Small and Medium Enterprises and Communications Can the Deputy Prime Minister update Parliament on the efforts being undertaken to ensure a secure ITC Government Network.
- Hon. Premila Kumar asked the Deputy Prime Minister and Minister for Tourism and Civil Aviation Can the Deputy Prime Minister update Parliament on the works already undertaken under the Fiji Tourism Development programme for the North.
- Hon. Kalaveti Ravu asked the Minister for Environment and Climate Change Can the Minister update Parliament on Fiji's Initial Biennial Update Report (BUR) for submission to the United Nations Framework Convention on Climate Change (UNFCCC).

Written Questions

- 70/2025 Hon. Premila Kumar asked the Minister for Women, Children and Social Protection A total of \$171.3 million was allocated in the current budget for social protection programmes. Can the Minister inform Parliament on the following
 - (a) how much funding has been used to date under each of the following programmes Family Assistance, Child Protection, Social Pension, Disability Support, and Transport Assistance; and

(b) how many Fijians have received support under each of these programmes so far.

71/2025 Hon. Jone Usamate asked the Minister for Public Works, Meteorological Services and Transport – With the ongoing disruptions to the regular water supply leading to the engagement of water carting services to supply water to households, can the Minister inform Parliament on the following –

- (a) the total cost incurred for water carting per year from 2022 to 2024:
- (b) the number of trucks currently engaged in watercarting; and
- (c) the mode through which payments are made to the contractors providing this service.

72/2025 Hon. Hem Chand asked the Minister for Education – Can the Minister inform Parliament on the Ministry's policy regarding the employment of officers above the age of 60, including the number of such officers and their roles.

The responses to the Oral and Supplementary Questions were provided by the respective Ministers. The response to Written Question 70/2025 was tabled by the Hon. Leader of the Government on behalf of the Hon. Minister for Women, Children and Social Protection. The response to Written Questions 71/2025 and 72/2025 would be submitted in accordance with Standing Order 45(3).
