

PARLIAMENT OF THE REPUBLIC OF FIJI

MINUTES

of Proceedings of Parliament at Suva on Thursday, First day of May, 2025

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.

3. <u>ATTENDANCE</u>

5. COMMUNICATIONS FROM THE CHAIR

The Hon. Speaker welcomed all Honourable Members to the sitting, those seated in the gallery and those watching the live proceedings on television and the internet. Hon. Speaker also welcomed another group of PL 100 School of Law and Politics Students from the University of the South Pacific.

Hon. Speaker informed all Honourable Members that the secretariat had received the written response from the Deputy Prime Minister and Minister for Finance and Strategic Planning, National Development and Statistics the Hon. Prof. Biman Prasad, to Written Question 11/2025 asked by the Hon. Inia Seruiratu. The response had been conveyed to the Hon. Leader of the Opposition and a copy uploaded on the Parliament's website.

Hon. Speaker also informed all Honourable Members that the back-to-office report for the 150th Inter-Parliamentary Union Assembly, which was held in Tashkent, Uzbekistan was available in the Library for perusal and reference.

6. PRESENTATION OF REPORTS OF COMMITTEES

- (b) what disciplinary actions have been taken against drivers found at fault, including the number of drivers surcharged and the total value of surcharges to be recovered.

The Minister for Employment, Productivity and Workplace Relations the Hon. Agni Singh moved pursuant to Standing Order 85(1) that the Work Care Bill 2025 be read a second time.

A Bill for an Act to establish the Work Care Fund and provide for compensation benefits for injured workers and pupils, and for related matters (Bill No. 7 of 2025).

Hon. Speaker referred the Bill to the Standing Committee on Economic Affairs pursuant to Standing Order 85(4)(a), and that the Standing Committee must report back to Parliament at the next sitting.

(c) <u>SECOND READING OF THE ACCIDENT COMPENSATION (AMENDMENT)</u> <u>BILL 2025</u>

The Minister for Employment, Productivity and Workplace Relations the Hon. Agni Singh moved pursuant to Standing Order 85(1), that the Accident Compensation (Amendment) Bill 2025 be read a second time.

Motion seconded.

Yes – 33 No – 11 Not Voted – 10 Abstention – 1

A Bill for an Act to amend the Accident Compensation Act (Bill No. 8 of 2025).
