

# PARLIAMENT OF THE REPUBLIC OF FIJI

# **MINUTES**

of Proceedings of Parliament at Suva on Tuesday, Twenty-ninth day of April, 2025

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.

#### 4. CONFIRMATION OF MINUTES

#### 5. COMMUNICATIONS FROM THE CHAIR

The Hon. Speaker welcomed all Honourable Members to the sitting, those seated in the gallery and those watching the live proceedings on television and the internet. Hon. Speaker also welcomed another group of PL 100 School of Law and Politics Students from the University of the South Pacific.

Hon. ### 6. PRESENTATION OF REPORTS OF COMMITTEES

#### (a) Standing Committee on Social Affairs

The Chairperson of the Standing Committee on Social Affairs the Hon. Iliesa Vanawalu tabled the Committee's Consolidated Review Report on the Ministry of iTaukei Affairs 2017-2019 and 2019-2022 annual reports.
