

PARLIAMENT OF THE REPUBLIC OF FIJI

MINUTES

of Proceedings of Parliament at Suva on Tuesday, Fifth day of August, 2025

- 1. The House met at 10.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.
