

PARLIAMENT OF THE REPUBLIC OF FIJI

MINUTES

of Proceedings of Parliament at Suva on Wednesday, First day of October, 2025

- 1. The House met at 9.30 a.m. pursuant to adjournment.
- 2. Hon. Speaker took the Chair and read the Prayer.

3. <u>ATTENDANCE</u>

5. COMMUNICATIONS FROM THE CHAIR

The Hon. Speaker welcomed all Honourable Members, those seated in the gallery, and those following the proceedings through television and online platforms.

Request for Extension – Standing Committee on Economic Affairs

The Hon. Speaker also advised the Honourable Members of the request from the Chairperson of the Standing Committee on Economic Affairs, which was agreed to by the Business Committee, for an extension of reporting back time on the following Bills –

- (a) Work Care Bill 2025; and
- (b) Accident Compensation (Amendment) Bill 2025.

The request was unopposed by all Honourable Members and the Standing Committee was informed to report back on the two Bills at the November–December sitting period.

6. PRESENTATION OF REPORTS OF COMMITTEES

(a) Standing Committee on Social Affairs

(i) The Chairperson of the Standing Committee on Social Affairs the Hon. Iliesa Vanawalu tabled the Committee's Consolidated Review Report on the 2018-2019, 2019-2020 and 2020-2021 Fiji Higher Education Commission Annual Reports.

The Chairperson of the Standing Committee on Social Affairs moved a motion without notice pursuant to Standing Order 121(5) that a debate on the content of the report would be initiated at a future sitting. The motion was seconded and agreed to unanimously.

8. QUESTIONS

Oral Questions

Hon. Faiyaz Koya asked the Minister for Fisheries and Forestry – In light of the EU relaxing the restrictions on rules of origin for our fish, can the Minister inform Parliament if Fiji has been able to swiftly agree with its Pacific Island neighbours on more supply of fish to PAFCO to process.

Hon. Jovesa Vocea asked the Prime Minister and Minister for Foreign Affairs, Civil Service and Public Enterprises – Can the Prime Minister update Parliament on the Memorandum of Understanding on the Deployment of the Republic of Fiji Security Personnel to Solomon Islands.

- Hon. Semi Koroilavesau to ask the Minister for Defence and Veteran Affairs Can the Minister inform Parliament how is Government improving the surveillance of our EEZ and territorial waters, to address the drug trafficking that is conducted by ships at sea in Fiji.
- Hon. Lenora Qereqeretabua asked the Minister for Employment, Productivity and Workplace Relations Can the Minister update Parliament on the progress in recruiting a fourth Country Liaison Officer (CLO) for Australia, and the appointment of the first CLO for New Zealand under the Recognised Seasonal Employer (RSE) scheme.
- Hon. Vijay Nath to ask the Minister for Rural and Maritime Development and Disaster Management Can the Minister update Parliament on the Ministry's current plans regarding the development and construction of evacuation centres across the country.
- Hon. Ratu Josaia Niudamu to ask the Deputy Prime Minister and Minister for Tourism and Civil Aviation Can the Deputy Prime Minister update Parliament on the progress and key developments of the Civil Aviation Master Plan.
- Hon. Virendra Lal asked the Minister for Public Works, Meteorological Services and Transport Can the Minister update Parliament on why certain entities like TFL and WAF are allowed to dig up perfectly good roads to carry out their projects or maintenance work.
- Hon. Ratu Rakuita Vakalalabure asked the Minister for Housing and Local Government Can the Minister update Parliament on the status of the New Town Development Programme, particularly with the ongoing projects in Nabouwalu, Keiyasi and Seaqaqa.
- Hon. Jone Usamate asked the Minister for Public Works, Meteorological Services and Transport What plans are in place to repair the hybrid electricity system in Namara, Kadavu that was originally put in place by KOICA.
- Hon. Iliesa Vanawalu asked the Minister for Agriculture Can the Minister update Parliament on the Memorandum of Understanding (MOU) recently signed to develop agriculture in Naselesele, Taveuni.

Written Questions

- Hon. Premila Kumar asked the Minister for Justice and Acting Attorney-General Can the Minister provide up-to-date statistics on the Fiji Independent Commission Against Corruption (FICAC) caseload for the years 2023 to June 2025 for each year as follows
 - (a) the total number of complaints received;
 - (b) the number of cases currently under investigation and those at the prosecution stage; and
 - (c) the number of successful convictions recorded.

Hon. Ratu Isikeli Tuiwailevu asked the Deputy Prime Minister and Minister for Trade, Co-operatives, Micro, Small and Medium Enterprises and Communications – Can the Deputy Prime Minister inform Parliament on the following, with respect to the Young Entrepreneurship Scheme (YES) for the financial years 2023–2024 and 2024–2025 –

- (a) the total number of applications received;
- (b) the total number of applications approved, funded and declined; and
- (c) provide the reasons for any applications that were declined.

Hon. Parveen Bala asked the Minister for Health and Medical Services – Since the inception of Aspen Hospital, Lautoka, can the Minister inform Parliament on the following –

- (a) how many cardiac procedures have been carried out to date;
 and
- (b) how many angiograms have been carried out to date.

The responses to the Oral and Supplementary Questions were provided by the respective Ministers. The Hon. Speaker informed Honourable Members that the following questions had been withdrawn: Oral Questions 157/2025 and 160/2025. The Hon. Speaker informed Honourable Members that Oral Question 159/2025 is deferred to a later sitting.

The responses to Written Questions 165/2025 and 167/2025 were tabled by the respective Ministers. The response to Written Question 166/2025 would be tabled at a later sitting date.

9. CONSIDERATION OF BILLS

The Hon. Speaker informed Honourable Members that following extensive consultations with the Chairperson and Deputy Chairperson of the Standing Committee on Foreign Affairs and Defence, it had come to his attention that the Standing Committee's report on the Trademarks (Amendment) Bill 2025 required further scrutiny to ensure that the recommendations were comprehensive, and that in the interest of upholding the integrity of the legislative process that the Standing Committee pursues further scrutiny.

There were no objections and accordingly, the Hon. Speaker informed the House that the Standing Committee's report on the Trademarks (Amendment) Bill 2025 was withdrawn; the Standing Committee would undertake additional review and analysis of the Bill; and would present a revised report to Parliament at a later sitting date.

Motion debated.

Question put.

Motion agreed to unanimously.

(c) The Chairperson of the Standing Committee on Foreign Affairs and Defence the Hon. Lenora Qerequeretabua moved that Parliament debates the 'Review Report on the Fiji Police Force 2020–2021 Annual Report' which was tabled on 18 July 2025.
