CALL FOR FACE TO FACE OR WRITTEN SUBMISSIONS

The Standing Committee on Justice, Law and Human Rights ('**Committee**') has commenced its review of the ***Education Bill (Bill No. 34 of 2025)***, ***Criminal Records Bill (Bill No. 41 of 2025)***, and the ***National Referendum Bill (Bill No. 46 of 2025)***.

Education Bill (No. 34 of 2025)

The Education Bill 2025 ('**Bill**') seeks to repeal and replace the Education Act 1966. It also seeks to repeal the Higher Education Act 2008 and the Fiji Teachers Registration Act 2008 to bring higher education and teacher registration matters under a single education umbrella legislation.

Criminal Records Bill (No. 41 of 2025)

The Criminal Records Bill 2025 ('**Bill**') provides for certain convictions to be spent or expunged and, fixed penalty offences to be expiated to give rehabilitated individuals a clean slate in relation to criminal records.

National Referendum Bill (No. 46 of 2025)

The National Referendum Bill 2025 ('**Bill**') seeks to provide a framework for the conduct of a national referendum in Fiji.

In that regard, the Committee cordially invites any interested person or institution wishing to provide their views and comments on the Bills, to attend a walk-in consultation on the following dates;
