SCHEDULE — MOTION FOR DEBATE

1. Minister for Finance, Commerce and Business Development to move for the purpose of section 145(1) of the Constitution and pursuant to Standing Order 131, that Parliament approves –
 - (a) Government guarantee for the Fiji Development Bank (Bank) borrowings for the 12-months period from 1 March 2026 to 28 February 2027 (Guarantee Period) through the issuance of short and long-term bonds, promissory notes, term deposits, any Reserve Bank of Fiji financing facility and other short-term borrowings;
 - (b) the increase in Government guarantee limit for the Fiji Development Bank borrowings of \$190 million for the period 1 March 2026 to 28 February 2027 (Guarantee Period), by \$30 million to \$220 million; and
 - (c) that the Bank pay a guarantee fee of 0.075% on the cumulative utilised guarantee.
